Action (Consent): 9. LEAP Implementation Grant Application

WHEREAS, the State of New Jersey has appropriated \$10 million for Shared Services and School District Consolidation Study and Implementation Grants to assist local units with the study, development and implementation of new shared and regional services; and

WHEREAS, the Department of Community Affairs, Division of Local Government Services (DLGS) is tasked with administering these grant funds through the Local Efficiency Achievement Program (LEAP); and

WHEREAS, \$2 million in LEAP Implementation Grant funds has been set allocated to support costs associated with school district consolidation studies; and

WHEREAS, the Township of Woolwich, Township of South Harrison, and Borough of Swedesboro have determined to evaluate whether the Kingsway Regional, East Greenwich Township Elementary, South Harrison Township Elementary, Swedesboro-Woolwich Elementary, and Logan Township School Districts may be able to attain improved educational quality and efficiencies through consolidation or regionalization; and

WHEREAS, a formal study must be undertaken to accomplish this objective; and

WHEREAS, the Kingsway Regional School District has agreed to be the lead entity in conducting this study and will submit the application for financial support for this study to DLGS on behalf of all participating units.

NOW, THEREFORE, BE IT RESOLVED by the Kingsway Regional School District Board of Education, that the Kingsway Regional School District will apply for a LEAP Implementation Grant to support the undertaking of a school district regionalization study on behalf of itself, and on behalf of the Townships of Woolwich and East Greenwich, Borough of Swedesboro, and School Districts of East Greenwich, Swedesboro-Woolwich, South Harrison, and Logan.

Action (Consent): 10. 2020-2021 Budget Adoption

BE IT RESOLVED, that the Kingsway Regional School District Board of Education adopt the 2020-2021 budget as follows :

General Fund (10) \$42,898,609 Special Revenue Fund (20) \$625,000 Debt Service Fund (40) \$3,448,597

Total All Funds \$46,972,206

With \$23,030,608 to be raised in taxes for the General Fund and \$2,171,632 to be raised in taxes for the Debt Service Fund for a total of 25,202,240 to be raised in taxes.



WHEREAS, the Kingsway Regional School District Board of Education recognizes the need to utilize an enrollment adjustment in the amount of \$315,290 to increase the general fund tax levy above the two percent (2%) cap; and

WHEREAS, the Kingsway Regional School District Board of Education may establish, for regular school district business travel only, an annual threshold of \$1,500 per staff member where prior Board approval shall not be required unless this annual threshold is exceeded in the budget year (July 1 - June 30); and

WHEREAS, the Kingsway Regional School District Board of Education has elected to exclude travel expenditures supported by federal funds pursuant to N.J.A.C. 6A:23A-7.3(a)2; and

WHEREAS, the Kingsway Regional School District Board of Education authorizes travel and related expense reimbursements in accordance with N.J.A.C. 6A:23A-7.3(a)1, to a maximum of expenditure of \$100,000 for all staff and board of education members.
