WHEREAS, James R. Mueller's service has left a permanent and positive impact on the Kingsway Regional School District by providing a learning environment that will allow Kingsway students to excel in the future; and,

WHEREAS, throughout his many years of service, James R. Mueller has served the students and residents of The Townships of East Greenwich, Woolwich, South Harrison, and Logan and the Borough of Swedesboro with fairness and dedication; and,

WHEREAS, James R. Mueller's leadership and dedicated service to our school community make it appropriate and fitting for the Kingsway Regional School District to remember him, and to honor his commitment to our District; and
