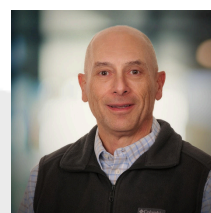

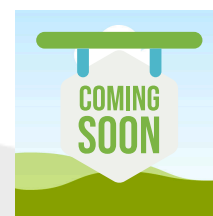

At a Special Meeting on Monday, May 20, 2024, the Board conducted interviews for the Zone #1 Trustee position.
