VI. PRESENTATION

English, Social Studies, Business. Barry Bachenheimer, Val Mattessich **World Language Update** Joe Orlak, and Argine Safari

Ms. Stephans asked who comes up and develops the courses and if textbooks or other resources are used.

Mr. Orlak indicated that there is a template and they need to meet certain criteria such as state learning standards, types of assessment, resources which can be online or hard resources. The curriculum is developed by the business teachers with his guidance. He mentioned that it's a three year process. Mr. Orlak said that textbooks are used, however periodicals like Harvard Business Review among others are used.

Dr. Bachenheimer added that a representative from CAPS wrote to him that he was very impressed with the program and the leadership. The representative believed the program to be one of the best in the country.

Mrs. Martin thanked the supervisors and Dr. Bachenheimer for an impressive presentation. She is proud to serve on the Board and proud to have her children exposed to all of the programs.

Mr. Blundo commented that this is his favorite time when he hears about all the wonderful programs and especially the enthusiasm that each of the supervisors displayed. Mrs. Martin added that the internship program has grown exponentially and is grateful that it has provided an opportunity for all students to participate.

VII. COMMENTS FROM THE PUBLIC

Ms. Carolee Adams of Montvale spoke about Policy 5722, student journalism. She mentioned a Senior Day where they were able to ask questions. She referenced Mr. Jasper's class where the students asked the seniors questions. One question was the kind of advice for the students. Some recommended traveling. Ms. Adams, who was editor for her school paper, advised the students to get information from more than one source and it should be different sources. She wondered if the policy was triggered by the new state bill about civil literacy. She asked if the policy is new or revamped.

Ms. Bilotti indicated that the policy is related to a different legislation, Public Law 2021, Chapter 309 18A:36-45 which is meant to expand the rights of student journalism. It specifically does not want schools to impose undue burden on student journalists. This will allow students to write about anything unless there is a concern about danger to themselves or others.

Mr.Usami mentioned that the tentative budget is due to the county by March 20. He indicated that the resolution has a capital reserve withdrawal for capital projects, a maintenance reserve withdrawal for required maintenance activities and a health care adjustment which allows the district to increase tax levy cap above 2%. He said the tax levy increase will be 3.27%. He commented that the increase was due to health care increase and the adjustment only covers a portion of the increase. He mentioned that transportation costs skyrocketed this year. He hopes that the transportation costs have stabilized, so it won't be an issue next year. He added that special education tuition has increased and lastly prices have gone up due to inflation.

Mr. Blundo commented that this was the toughest budget during his time on the Board. He mentioned that this is a tentative budget and changes can be made, but this needs to get into the county due to the deadline. He mentioned that Ms. Bilotti is looking at a different way to configure transportation that may reduce costs.
