#### VII. PRESENTATION

**State Testing Report -** Dr. Bachenheimer and Ms. Merk - <u>presentation/report</u>

Mr. Stankus asked if the internship program has had an opposite effect on the DLM results.

Ms. Merk believed it has due to a strong social skills program in the students' first two years of high school to develop their "soft" skills. The students are into the community based program.

Mr. Weaver asked if the district is collecting data from students who are not going to a two or four year college. How well is the district preparing students who choose a career path after graduation.

Dr. Bachenheimer referred to the strength of the internship program and the number of students who are hired by the internship employer as well as going into the trades or military. The district has added business and vocational courses to better prepare those students.

Ms. Merk added that students with IEPs were in a cohort study which was required by the state. The district contacted those students one year after graduation to gather data on their status. She mentioned that the district did very well in this study and she would share the report with Ms. Bilotti and Dr. Bachenheimer, and they may share with the Board.

Mr. Stankus asked about two standards and what they addressed.

Dr. Bachenheimer said he would get the answer. He added that this was a pilot test and the goal was to address all the standards.

Ms. Carolee Adams of Montvale commented that the state test scores do not break out scores for bi-racial and test does not break out by black students. She believes that is an oversight that needs to be corrected at the state level. She mentioned in a piece by NJ Spotlight that there was debate about whether counseling and mental health should be addressed in schools. She indicated that the district does a good job of it and it should remain in schools.

#### XIII. OLD BUSINESS

Ms. Molinelli commented about Project Search which was highly successful for students. She indicated that she is the executive director of the Bergen County Workforce Development that sponsors the program, but she does not have any say with any of the schools that refer students to the program.

Mr. Blundo commented that prior to the change in administration, the Board received a draft agenda on Thursdays before the board meetings. He indicated that a draft agenda will go out on Thursdays prior to a meeting. He said to keep in mind that there could be changes when the final agenda comes out.

#### XIV. NEW BUSINESS

Dr. Blundy asked when the board committees will start since she has not seen a schedule.

Ms. Bilotti indicated that they have slowly scheduled them as needed. She mentioned that she only received responses from two members regarding general availability. She asked for input, otherwise she would begin drafting a schedule. She mentioned that there was a Facilities meeting, a Finance meeting scheduled for next week and a Policy meeting, and Curriculum meeting as well. Dr. Blundy commented that she would like to serve on the Wellness Committee.

Mr. Blundo said that Ms. Bilotti will match people's interests to the committees as best she can. He added that since it's a transition year the process may have taken a little longer.

Mr. Blundo mentioned that the Finance Committee has been discussing the potential of acquiring property across the street from Pascack Hills. He mentioned the discussion

about the 18-21 year old life skills program which is housed in Hillsdale and the potential of expanding the program.

Mr. Usami gave a general update on the capital projects and how it affects the capital reserve fund. He indicated that capital projects had been delayed for two years and for some projects more than two years. The capital reserve funds were budgeted in the previous two budgets and now the costs have gone up significantly. Robert Donahue, the Director of Facilities estimated that the increase is almost \$1.3 million. He mentioned the audit and how he will discuss it with the Finance Committee and recommend adding more to the capital reserve. The end result of after factoring the additional funds needed for the previously mentioned estimate is that an estimated \$3.8 million will be in the capital reserve with a plan to budget two roof projects in 2023-2024 which leave an estimated \$2.1 million in capital reserve. He added that there may be potential items on the horizon and the two auditorium projects may need additional funding which is not known at this time.

Ms. Molinelli asked if \$2.1 million in the capital reserve is enough compared to other districts. She feels that it's a safety net for the district.

Mr. Usami indicated that capital reserve is only for capital projects and outside of the operating budget. He went over the audit and that the district is allowed to keep 2% plus some other things for a rainy day. Due to COVID, the state allowed districts to keep 4% in each of the two years. Last year, he indicated he recommended 2% and the Board agreed. This decision was reinforced by the auditor since the district is healthy financially. The auditor agrees with keeping 2% this year as well. He said that the district manages the budget well to take excess surplus for a future budget, in this case for the 2023-2024 budget and the remainder of excess surplus goes into capital and maintenance reserves. He added that typically the district puts in \$3-\$4 million into capital reserve and uses it for capital projects for the schools or the district.

#### XV. COMMENTS FROM THE PUBLIC

Citizens are invited to make comments and are limited to three minutes, according to the Pascack Valley Regional High School District Board of Education policy number 0167. Persons wishing to speak must, upon being recognized, rise, sign in and state their name and town of residence.

Ms. Carolee Adams of Montvale mentioned that \$1.7 billion dollars will be going to schools throughout the country for mental health. She mentioned programs such as mixed martial arts such Taekwondo. She mentioned that instead of medications, physical activities like self defense can support sound mind sound body and self confidence. She indicated that 750,00 students from 12-18 years old experienced violent crimes that could have been avoided with self defense. The Board has a goal regarding Wellness for students, but she has not seen or heard anything about personal safety through self defense.
