**NOW, THEREFORE, BE IT RESOLVED** that the Board hereby rejects one bid received for the Project because the bid substantially exceeded cost estimates and were unreasonable as to price.

**BE IT FURTHER RESOLVED** that the Board Secretary/Business Administrator is hereby authorized to re-advertise the Project, in the best interests of the School District.
