VI. BUDGET PRESENTATION BY SCHOOL BUSINESS ADMINISTRATOR AND SUPERINTENDENT OF SCHOOLS

Presentation

Dr. Blundy asked if the district looked at getting out of the state plan.

Mr. Usami indicated that they did. The district received its experience from the state and it indicated the insurance company paid about \$3 million dollars more in claims than it paid in premiums over a two-year period. Thus, no insurance will entertain taking on the district. He said perhaps in two years they can revisit it.

WHEREAS, Skopye informed the Board that there was a material mistake in its bid and requested that the Board release Skopye from its bid; and

WHEREAS, the architect has verified that a material mistake was made by Skopye in its bid; and

WHEREAS, the bids submitted by Tri-Plex Industries, Inc. and Lanyi & Tevald Inc. exceeded the cost estimate and budget for the Project

WHEREAS, it is recommended that the Board reject the bid for the Project for exceeding the cost estimate and budget for the Project.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby rejects the bids received for the Project.

BE IT FURTHER RESOLVED that the Business Administrator/Board Secretary is hereby authorized to re-advertise for the Project in accordance with <u>N.J.S.A.</u> 18A:18A-5(c).
