Mr. Blundo commented that he and Mr. Fronte attended Pascack Valley had some common friends, though he did not know Mr. Fronte. He said Mr. Fronte brought a different perspective to the Board. He mentioned that he stood on accountability and letting the data drive the decision. He mentioned that Mr. Fronte served during the two of the most tumultuous years of the Board. He appreciated him standing up listening to the public and dealing with many emotions. He added that Mr. Fronte will be missed and he would be welcomed to come back.

Mr. Fronte was presented with a plaque.

VII. PRESENTATION

Annual Audit Presentation – Bud Jones of Nisivoccia, L.L.P. – CAFR and AMR

Mr. Jones presented the FY 21 audit to the Board. In addition, this was another segment of the Board training in school finance. Mr. Jones reviewed the Introductory section which includes the Letter of Transmittal, organizational chart, roster of officials, consultants and advisors, information about the district, schools, initiatives and status of the initiatives, curriculum and instruction of the programs, special services, and the economic conditions. Next, the financial schedules: A schedule which is accrual basis financials, B schedule which is the governmental funds. He mentioned the unassigned fund balance went from the allowable 2% to 4% due to the pandemic. He mentioned Exhibit J-13 which represents the district's debt position. He said the district is allowed \$250 million in debt and the district currently has about \$14 million. He also reviewed the Auditor's Management Report. He indicated that there are no audit recommendations. He mentioned that there are a few management suggestions that his firm makes to all clients. He commented about reporting of funds, to be careful with the recent influx of federal funds and how they are spent and sick and vacation leave. Mr. Jones thanked the district staff for their professionalism and providing the necessary information for the audit.

Mr. Blundo asked if the district is in compliance since there are no recommendations.

Mr. Jones said that yes based on what they are required to test. It's not everything.

Mr. Blundo asked about the discrepancy from last year's \$2.2 million to this year's \$900,000.

Mr. Jones explained that the calculation changed from a limitation of 2% to 4%.

Mr. Usami commented that the district will add about \$1.1-\$1.2 million to the \$900,000 for the 2022-23 fund balance. That would leave the district close to the 2%.

Mr. Jones added that it is close to the district's budgeting philosophy.

Mr. Fronte commented that this was discussed at a recent Finance Committee meeting.

XIII. OLD BUSINESS

Finance Committee Report - Report

Curriculum & Instruction, and Technology Committee Report - Report

Mr. Blundo asked if the laptops are due to be replaced for next September.

Mr. Stankus mentioned that the laptops are holding up well and may be pushed back.

Dr. Fishbein indicated that the new models have not come out and the district is looking for certain components such as additional ports. It's possible that the year could be started with the existing laptops and then changed over during the year.

Mr. Stankus added that the laptops are built to last, so they could be used for a little longer, if needed.

Mr. Weaver asked if the laptops are leased or purchased and if there is a return program for credit towards the new laptops.

Dr. Fishbein said they are on a lease purchase and Mr. Usami indicated that there is a program to receive credit for the laptops that are being replaced.

Mrs. Martin added that it was mentioned that repairs have gone up, so there is some wear and tear.

Mr. Blundo commented that the laptops cannot be purchased from the district. They may be purchased from the company buying them back, but it will not be the specific student's laptop.

Mrs. Martin indicated that the teaching assistant will not have access to the IEPs or grading test or assessments.

Mr. Stankus mentioned that it goes through student training, teacher, supervisor.

XIV. NEW BUSINESS

Mr. Blundo mentioned that Park Ridge and Emerson are combining its football teams. He said that there may come a time to look at combining programs. He suggested that it may be time to resurrect the Activities Committee with the athletic directors to have a pulse on what may be coming. The options would be to eliminate a program or regionalize based on the numbers.

Mrs. Varghese asked in what circumstance would lead to this.

Mr. Stankus said it would be based on the program enrollment.

Mr. Weaver said it falls under the umbrella of equity for co-curricular and athletics which was discussed at the Board Retreat. He indicated that there were student concerns about equity with some programs. He commented that he is not sure if enough has been done with this in regards to facilities.

Mr. Blundo said he will push for the Activities Committee. He believes what is being discussed would be better served in this committee rather than the Equity Committee.

Mr. Stankus confirmed that equity was going to be looked at by the athletic directors and added that the committee should be brought back.

Mrs. Varghese asked why the committee was disbanded.

Mr. Blundo indicated that the updates were focused on what occurred with the teams which is what the student reps reported. He said any extra-curricular activity was discussed not just athletics.

Dr. Fishbein suggested that the Activities Committee be an ad hoc committee with a limited term.

Mrs. Varghese suggested each committee should discuss activities.

Mrs. Martin pointed out that the athletic directors couldn't attend all committee meetings. That would be a great burden.

Mr. Blundo suggested having the athletic directors come to a regular board meeting and give a state of the state on extra-curriculars.

Mr. Stankus mentioned that the Curriculum & Instruction and Technology Committee has a larger group who meet twice a year. The larger Activities Committee could hit wellness, finance, equity, etc.

Mr. Fronte thanked the people of Hillsdale for giving him the opportunity to represent them. He thanked past and present board members and district wide employees for their hard work and diligence.

XV. COMMENTS FROM THE PUBLIC
