# III. COMMENTS FROM THE PUBLIC

Citizens are invited to make comments regarding agenda items and are limited to five minutes, according to the Pascack Valley Regional High School District Board of Education policy number 0167. Persons wishing to speak must, upon being recognized, rise and state their name and address.

Rebecca Riley, Hillsdale class of 2011, commented on item 10 - PV Indian Mascot. She affirmed that both times the board has discussed this issue they have kept the mascot as the Indian. It is offensive for native Americans. The school mascot should not be founded on racism and hate.

Ms. Olivia Jones of River Vale addressed the board regarding the mascot. She implores the board to act. The time for change is now. Every person in the community should be valued. She stands in opposition to the use of the Indian to represent Pascack Valley. One Spirit has outlined the issue.

Leah Jerome, a teacher at Pascack Valley and co advisor to the One Spirit Group, spoke to the board. The district goal is to advance the work of inclusivity. We cannot teach that stereo typing is acceptable. We have been empowered by data. We are leaders. This is an opportunity to continue to be leaders.

Steve Myers issued a statement today. The psychological impact of this mascot must be recognized; it is a racist stereotype of indigenous people. Immediate retirement of all native mascots in logo and in name must take place. This impacts a marginalized group and harms Native American youth.

Charlene Schwartzman thanked the board. The board has an opportunity to do the right thing. It is time to change the mascot. We should be willing to take a stand and do what is hard. Let's choose a mascot that we can all be proud of.

Adam Shapiro, a River Vale resident asked why are we still discussing this issue in 2020. Over 20 years ago the NAACP passed a resolution calling for the end of Native American mascots. Many other organizations have followed suit. This is not a new issue. This is not just a flare up. We should have addressed this earlier.

Mark Russo, resident of Woodcliff Lake, read a joint statement from the five supervisors of instruction asking for the immediate retirement of the Indian. See, value and seek to learn from others that are different.

Howard Megdal of River Vale shared a personal experience. He did not want his children to wear the shirts with the Indian mascot. It did not reflect who the community really is.

Ambrogio Mclean, a resident of River Vale, spoke about the sense of community that should motivate the board to make the change to the mascot. It is frustrating that it has taken so long to change the mascot. We need to listen to everyone and work together. This mascot mars what Pascack Valley stands for.

Valerie Santo, an English teacher at Pascack Valley, asks her students to be conscious of human rights violations. She would be remiss to not support changing the mascot. The district goal is equity.

Sara Takubo, a resident of River Vale, has been embarrassed of the school because of the mascot. The board has a responsibility to teach what it means to be an American. A country of diverse peoples and immigrants.

Desmond Von Toble, a resident of River Vale, shared his experience as an athlete in the district. The mascot does not define the teams.

Regina Guzzo, an alumnus who studies historical trauma, spoke to the board. The mascot unintentionally represents this group of people in a poor light. It is harmful to native Americans and their culture.

Karen Jones, a River Vale resident, the mother of Olivia Jones, is very proud of One Spirit.

Sam Riley, a Hillsdale resident, opposes the mascot of Pascack Valley High School and hopes the board will reconsider the mascot.

Erica Franceski, a member of the district equity team, spoke to the board about advancing equity in the district. Please retire the Indian mascot.

Allison Toledo, a resident of Hillsdale, addressed the board about the mascot. She would not wear Pascack Valley gear at Harvard because she was embarrassed. We have the ability to do better.

Dana Corasaniti, a teacher at Pascack Valley, addressed the board about the mascot which is a personification of school spirit. The mascot needs to be retired.

Caitlin Murphy, at teacher at PV, addressed the board. She is not proud of the schools' mascots. They should both be retired. Thank you to One Spirit.

Jacob Ricco, a resident of River Vale, addressed the board about the school logo. We must be actively against racism.

Sklar Fay, from River Vale, spoke about the conversation that was had four years ago regarding this same issue. This is not a new trend. We are calling for this change again.

Shauna McLean, a Hillsdale resident, continued the conversation about the mascot. Removing the Indian from the letterhead was admitting the mistake. The mascot is racist. Removing it will heal us.

Nina Henry, a resident of River Vale, discussed the atrocities that happened to Native Americans. Change the mascot.

Madeline Miller, a robotics team member, has to defend the Pioneers' name for the team.

Allison Gordon, an alumnus of the high school, discussed the mascot issue. Changing the mascot is the bare minimum that should be done. This should have happened in 2015.

Natalia Chinchilla from Hillsdale represents the PV World Culture Club and PV Asian Culture Club. She discussed the mascot issue. The mascot does not pay tribute to Native Americans. It is time to change the mascot.

Alex O'Neill a Hillsdale resident, discussed the mascot issue.

Alex Brennan a Hillsdale resident, living in Northern Ireland, said that it should be clear that changing the mascot is the only option, on the basis that it is wrong.

Jamie Ryu, a resident of River Vale, experienced racism because she is Asian. The mascot is racist. It sends a signal that the behavior is OK. It is disheartening that the board didn't change the mascot in 2015.

Kiera Foster, a resident of Hillsdale, discussed the mascot issue. Traditions can change.

Kate Henderson a resident of Hillsdale. We have a responsibility to make the change with the mascot. Everyone should feel safe. The mascot is inappropriate. Pride is more important than tradition.

Ryan Walter, a teacher from Pascack Valley, commented on the job of educators to make students feel welcome and safe. Maintaining and supporting this mascot does not accomplish this goal. The image of the Indian does not reflect the community.

Lucy Disalvo, a resident of Hillsdale, supports the change the mascot movement.

Olivia Stabile, a Hillsdale resident, feels as if no one has been listening. Having a racist mascot does not make me feel a sense of pride. Please change the mascot.

Mitchell Hirsch, a Hillsdale resident and medical student is proud of his education but not the mascot. This is long overdue.

Meghan Doody, a resident of Hillsdale, added that in college she won't wear her high school gear. Please change the mascot.

John MacHughan asked, Didn't One Spirit interview an Indian that had no problem with the mascot? However, let the students voice be heard and let them vote.

Ashley Shaaf, a resident of Hillsdale also is against the mascot.

Sarah Taminy a member of One Spirit implores the board to do the right thing. Remove the mascot.

Caleb Burleson a Hillsdale resident, thinks this mascot makes the school look terrible. There is no reason to keep this mascot.

Alice Urbiel, a resident of Hillsdale showed solidarity with the other speakers.

Kathryn Ng, a resident of Hillsdale, spoke of a personal experience. When she didn't stand during the chant at a game she got dirty looks. The Indian mascot perpetuates harmful stereotypes.

Adam Aloi, a resident of River Vale is disgusted that we are still having this conversation.

Jennifer Schneider from Hillsdale is also against the mascot.

Hana Shapiro, from River Vale, is deeply ashamed of the mascot.

Carlie Cattelona, is in support of changing the team name and the mascot.

Delia Collis, student body president at Pascack Valley, wants the mascot removed.

Rebecca Fontana, a Hillsdale resident feels that symbols are powerful. Remove the mascot.

N. Calianese from the Class of 2015 supports the removal of the mascot.

Hina Tazaki from Pascack Valley supports all the people in One Spirit. Remove the mascot.
