IV. ROUTINE MATTERS

Monthly Reports

Superintendent's Report: Dr. P. Erik Gundersen

Good evening. This is an unprecedented time for our district and our community and I would like to express our district's thoughts and condolences to the families who have been significantly impacted by the loss of a friend or loved one during this historic public health crisis.

To the health care workers, first responders, government leaders, grocery store clerks, volunteers and others who are assisting our community - thank you.

We are now entering our fourth week of remote learning. As you know, our district has a long history of utilizing technology in a meaningful way, but this complete shift to remote learning has been a herculean undertaking by our administrators, support staff and teachers. Their efforts have been remarkable and our students are responding well to their new learning modality.

Let me be clear - remote learning is far from an ideal method of teaching and learning. However, our students are watching how our teachers are providing innovative methods of teaching, are continually reflecting on our practice, and refining the way we teach our students.

Taking the lead on our shift to remote learning is our Regional Director of Curriculum, Dr. Barry Bachenheimer, who will speak to how we are continuing to educate our students in our new reality.

Dr. Barry Bachenheimer:

Dr. Bachenheimer gave a report on remote learning including news ways to increase student and teacher engagement. He emphasized flexibility. Supervisors are working with teachers to keep student work both manageable and reasonable. Counselors and child study teams continue to provide services virtually. Teachers, coaches and advisors are going above and beyond to engage the community. The staff will continue to adjust for the good of the students and are creating plans for contingencies. He thanked the faculty, support staff, and custodians for their commitment.

Thank you Dr. Bachenheimer to you, the instructional supervisors and our building administrators for leading the way and supporting our teachers.

I have been in close contact with local government officials, particularly the mayors of the four towns and appreciate their partnership and support. Some of the efforts we have made include, but are not limited to:

- Robotics and technology teachers have been utilizing our 3D printers to print face shields for first responders.
- Collecting masks, gloves, and goggles for County medical staff.
- The teacher's association spearheaded an effort to supply meals to the health care professionals at Hackensack University Medical Center at Pascack Valley.
- Serving as a host site for Vilatant Blood Services as the need for blood donations is at a critical point.

We do not know how long we will be engaged in remote learning, but please know that we are constantly reflecting on how we can improve learning for students and will continue to update parents and students of any changes. In addition, our administrative team is exploring ways that we may be able to adjust end-of-year activities for our graduating seniors. Of course, we will keep all parents and students apprised of any developments.

Shifting to the principalship of Pascack Valley High School:

Following the extensive search process for new principals at Pascack Valley and Pascack Hills, the Board approved an outside candidate to serve as the next Principal of Pascack Valley High School; however, the candidate changed his mind, and subsequently, at his request we rescinded his appointment. This unexpected change, in the midst of the global pandemic, left the Board and I in a difficult situation with regard to filling the vacancy for the Pascack Valley Principal as conducting a new and thorough search now would be nearly impossible.

In an effort to provide stability and proven leadership at Pascack Valley during these difficult times, I asked Mr. deMarrais if he would consider postponing his retirement and accept a reassignment to serve as the Pascack Valley Principal. After a great deal of consideration, Mr. deMarrais graciously accepted my request. Last evening, the Board approved to rescind his

resignation due to retirement and to reassign him as the Principal of Pascack Valley High School for the 2020 - 2021 school year.

Mr. deMarrais has nearly 20 years of administrative experience in our district and is well respected by his peers. He has a proven track record of highly effective leadership, especially in the areas of school climate and culture. He is well versed in our district vision and mission, and is enthusiastic about helping out our district team. I am grateful to Mr. deMarrais and look forward to working with him as the Principal of Pascack Valley High School, effective July 1, 2020.

2. Compensation for Bus Companies during COVID -19 Pandemic

WHEREAS, the Pascack Valley Regional Board of Education as LEA for Pascack Valley Region II, Council for Special Education has contracts with various bus companies and, due to the enactment of Executive Order 104 (Murphy) in response to the COVID-19 pandemic, schools have been closed to students until further notice; and

WHEREAS, the emergency closure of all schools in the district has also caused the suspension of services provided by bus companies to transport students to and from school; and

WHEREAS, bus company vendors may be forced to lay off bus drivers and cancel our routes for the future which will force the district to bid out all routes at a potential higher cost than offered in a renewal of the routes at the current prevailing Consumer Price Index (CPI) increase of 1.7%; and

WHEREAS, even though services aren't being currently rendered, the cost of not paying these contracts can potentially be more detrimental to districts than paying for the maintaining of these contracts in the future.

WHEREAS, in consideration for not terminating the Agreement with the Contractor since transportation services will no longer be necessary while schools are closed, the Board will agree to pay the Contractor ninety-percent (90%) of the remaining contract balance in accordance with the terms and conditions of the Agreement; and

WHEREAS, the Board's payment obligation shall be contingent upon the Contractor furnishing, on a monthly basis, copies of certified payroll records for each driver who was assigned to a route for the Board as of the last day student transportation services were provided prior to schools officially closing, establishing that the driver's salary was paid by the Contractor;

WHEREAS, the parties have amended the terms of the Agreement to memorialize and clarify the respective responsibilities and obligations of the parties as set forth above.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby approves any necessary Addendums reflecting the parties' obligations above.

BE IT FURTHER RESOLVED that the Board President and the Board Secretary are hereby authorized to execute necessary Addendums to the Agreements and any other documents necessary to effectuate the terms of this Resolution.

BE IT FURTHER RESOLVED that the Addendums shall be forwarded to the Executive County Superintendent for approval.

3. Opposing Delay in Transmission of Quarterly Property Tax Revenue to School Districts

WHEREAS, Assembly Bill 3902, currently pending in the State Legislature, would authorize the Department of Community Affairs to permit municipalities to delay the monthly transmission of property tax revenues to school districts during gubernatorial-declared emergencies; and

WHEREAS, New Jersey's public schools are highly dependent on property tax revenue to support education programs; and

WHEREAS, on average, local property taxes constitute close to 60% of public school revenue, with the percentage even greater in a significant number of districts; and

WHEREAS, a delay in payments from municipalities would result in a financial crisis for school districts, seriously disrupting the educational process—and bringing it to a halt; and

WHEREAS, although public school buildings are closed during the current health emergency, the education of our students is taking place through remote learning and home instruction; and

WHEREAS, continued timely transmission of school property taxes is critical for the education process to continue without interruption; and

WHEREAS, even though municipalities are designated as the authorities to collect property taxes, these taxes are levied for specific purposes—e.g., municipal, school, county, fire district—and these obligations must continue to be met; and

WHEREAS, as currently written, A-3902, which is intended to ease a financial burden on municipalities, would place a severe strain on school districts and the students and families that they serve; and

WHEREAS, the Pascack Valley Regional High School District Board of Education recognizes the impact of the current public health emergency on the state and local governments, as well as local school districts, but believes this legislation would worsen the situation for our communities.

NOW, THEREFORE, BE IT RESOLVED that the Pascack Valley Regional High School District Board of Education urges the State Senate and the Governor to oppose A-3902; and be it further

RESOLVED, that this resolution be delivered to Governor Phil Murphy, State Senate President Stephen M. Sweeney, Assembly Speaker Craig Coughlin; and the Pascack

Valley Regional High School District Legislative District's representatives in the state Senate and General Assembly; and be it further

RESOLVED, that copies of this resolution be sent to the New Jersey School Boards Association.

4. Emergency Procurement and Contract Modification Food Service

RESOLVED that the Pascack Valley Regional High School District Board of Education, at the recommendation of the superintendent, authorize the Business Administrator to sign the Letter of Understanding with Pomptonian Food Service to establish an emergency agreement to facilitate the feeding of students until June 30, 2020 during the COVID 19 crisis.

5. Approval to Pay Extra-curricular Stipends

WHEREAS, the Pascack Valley Regional Board of Education ("the Board") and the Pascack Valley Regional Education Association ("the Association") are parties to a employment agreement dated July 1, 2017 ("Agreement") in effect through June 30, 2020; and

WHEREAS, the Agreement provides that stipends shall be paid for extra-curricular activities, and

WHEREAS, due to COVID-19, the Pascack Valley Regional High School District has remained closed as of March 13, 2020; and

WHEREAS, as a result, in-person meetings, practices and competitive events have discontinued; and advisors, coaches and assistant coaches have maintained contact with, and instructed and encouraged individual activities for club and team members resulting in positive affirmation for students both socially and emotionally; and

WHEREAS, much preparation and planning for these extracurricular activities took place prior to the closing of school; and

WHEREAS, in consideration for not terminating the Agreement with the Association, the Board will agree to continue stipend payments to advisors and coaches through the duration through June 30, 2020, and shall not be precedent setting for future athletic and extra-curricular stipends; and

BE IT FURTHER RESOLVED that the Board Secretary is hereby authorized to pay stipends to board-approved advisors, coaches and assistant coaches as stipulated in the current agreement for the remainder of the 2019-2020 school year.

Mr. Scher asked if the district would be able to maintain programs if tax payments were delayed. Ms. Baxley responded.

Mr. Steinberg explained that he would be abstaining from item 5 because he wanted to wait for the upcoming legislation regarding payment of stipends.

Mr. Scher asked Ms. Baxley to explain the agreement with Pomptonian which was to be in place during the school closure. Ms. Baxley provided the necessary background.

Dr. Gundersen highlighted the remarkable efforts of coaches and advisors interacting with their students during the school closure. Mr. Stankus seconded that and commented that he was personally very pleased with his daughter's experience.

X. OLD BUSINESS

Board Committee Reports: Negotiations

Dr. Gundersen reported that a tentative agreement is in place and that we are waiting for the PVREA to present it to their membership. He was happy to announce the progress the committee had made and thanked all the parties involved.

Mr. Scher asked about the bees and commented on the substitute location where they are currently located until we are back on the school site.

XI. NEW BUSINESS

Mr. Scher asked Dr. Bachenheimer about grading. He noted that some districts have moved to a pass-fail system and others have gone to not allowing students to fall to a lower grade than the one they had before school was cancelled. Dr. Bachenheimer explained that the district would be using flexibility during the current virtual learning situation but would continue with the current grading system which was both reasonable and accountable.

Ms. Molinelli wondered if the college acceptance process had been interrupted by the pandemic. Dr. Bachenheimer replied that the colleges were still working on their same admissions schedule. Most of our students got applications in before the deadlines and many have already heard from their schools. There was not too much disruption.

Mr. Scher asked for an update on the status of capital projects and Ms. Baxley gave an overview of the current work schedule.

XII. COMMENTS FROM THE PUBLIC

Citizens are invited to make comments and are limited to five minutes, according to the Pascack Valley Regional High School District Board of Education policy number 0167. Persons wishing to speak must, upon being recognized, rise and state their name and address.

Mr. DeRosa, the council liaison, from Hillsdale spoke on behalf of the borough in thanking the district for the seamless transition to virtual learning. He also thanked Dr. Gundersen for hosting the blood drive at both high schools and for the continued support in bringing school meals to eligible students.

XIII. ADJOURNMENT

A motion was made by Ms. Bissinger to adjourn the meeting at 8:25 p.m. Mr. Fronte seconded the motion, which was unanimously carried.
