## IV. ROUTINE MATTERS

Monthly Reports

Superintendent's Report: Mr. P. Erik Gundersen

I would like to thank our summer staff members, administrative team, and counselors who worked throughout the summer to make the launch of the '18 – '19 school year a success! The smooth opening of the school year is because of their efforts to fully prepare our building and systems for students and staff.

For the second straight year our school counseling staff was staffed throughout the summer to provide resolutions to scheduling conflicts, assist students with emotional / mental health assistance, conduct individual freshman conferences for students and their parents, and offer seniors "college application boot camps" all prior to the beginning of the school year.

Today the Board of Education will approve the district and board of education goals for the 2018 – 2019 school year. These goals are built upon the prior work within the district, feedback and input from the administrative and supervisory team, and after deliberation and discussion at the annual Board of Education retreat in July. I am excited and encouraged by the direction of our district and thank the Board of Education for its support as we continue to move forward to develop an innovative educational experience that promotes student inquiry, and addresses the individual needs of our students.

Finally, I am excited to announce that our afternoon / evening SLEO III's are in motion. These were challenging positions to fill, but I would like to compliment the Hillsdale and Montvale police departments for working to hire exceptional, retired police officers who will be on site to protect our staff and students in the afternoon and evening hours. Montvale's evening SLEO III is already in place and Hillsdale's SLEO III will begin work at Pascack Valley High School in the coming weeks as he is finalizing some mandatory training.

Student Reports:

Matthew Friedman - Pascack Hills High School

Pascack Hills has been buzzing with excitement in these first few weeks of classes! On August 29th, we welcomed the Class of 2022 at Freshman Orientation. Student Government members helped those new to Pascack Hills find their classes, while members of Peer Leaders served as guides to the Hills community. On August 30th, all students returned to classes, and Hills Pride was truly in full force as seniors commemorated their last year of high school by painting their cars in Brown, Orange, and White.

Fall athletics are particularly popular this year with over 500 students, or 60% of the student body, participating in an autumn sport. When you add in Pep Band, Cheerleading, the fall play, and robotics, that number soars to over 70% for participation in fall extracurricular activities.

Our Cross Country team has had commendable success thus far, beating all 7 teams in their league at the Batch Meet on September 13th at Darlington County Park. Well done to our XC program!

Speaking of running, the Pascack Hills community is very excited about the donation of a new treadmill in the Fitness Center. A big thank you to the Pascack Hills PFA for this wonderful gift that has been welcomed with enthusiasm by our athletes and Physical Education staff and students.

Last week, the Pascack Hills Student Government organized our school's participation in a county-wide fundraiser: Day of Gold. Day of Gold started several years ago to raise money to support research at the Josephine Elle Hartung-Rispoli Research Lab at Hackensack Hospital. The lab hopes to find a cure for pediatric cancer, while also honoring 7-year-old Josephine, who the lab was named after. Overall, the PHHS community raised almost \$1100 last week, and we can't wait to see the breakthroughs made possible by this fantastic event.

In other news, clubs have started to meet and formulate plans for the year. The popularity of business-related clubs at Pascack Hills has continued to grow, with the Investment in Business Club seeing a record 110 students sign up, while DECA membership also increased to 165 students. To hear updates on student success in DECA, follow their brand new Instagram page, @phhs.deca.

Back to School Night was on September 20th, where parents and guardians were able to meet teachers, learn about academic programs and purchase merchandise from our student organizations! A good time was had by all.

The coming weeks are not short of excitement either, as we approach our first Pep Rally this Wednesday, Week of Respect starting on October 1st, Financial Aid Night on October 4th, and Fall NHS induction on October 30th.

All students will be able to continue this communication with students via Edmodo, a website for schools. This exchange program began in 2014 and we have since hosted this school in 2015 and 2017. The Early Childhood and Family Education students are working hard, planning and preparing lessons for the arrival of the Preschool children in early October.

The Interact Club held its introductory meeting, planned fundraisers, and held its first bake sale.

The Convention is titled "Next Steps" and hosts the 2018 State Teachers of the Year from all the U.S. states and territories. Josh Groban, "You've Got a Friend in Me" by Paul Newman, as well as several others. ## VI. COMMENTS FROM THE PUBLIC

Citizens are invited to make comments regarding agenda items and are limited to five minutes, according to the Pascack Valley Regional High School District Board of Education policy number 0167. Persons wishing to speak must, upon being recognized, rise and state their name and address.

Mayor Ruocco from Hillsdale emphasized that the district should reconsider giving a higher contribution for the SRO to Hillsdale. He commented on the positives of having an SRO in the district. He realized that the board has approved several other initiatives in the district to support safety in the schools. He went on to detail the expenditure of the SRO and commented that not only one district should be funding this resource and that

funding the SRO is to the detriment of the Hillsdale taxpayers. If the board doesn't think it adds sufficient value to the school please send that in a letter to the borough. Keep the school resource officer. It is about being a good neighbor to the host district.

Mr. Gundersen responded to the mayor. He thanked him and commented on their positive relationship. He expressed the board's opinion regarding the increase in reimbursement and explained that while the district supports the notion and the value of the SRO, as the officer builds relationships and helps in the classroom for driver's education, they believe the amount of the current contribution is appropriate. The officer is part time and also works at the middle school and at the police station. The educational benefit to the district is the crux of what the board compensates the borough for. Since the board believes a full time security presence is necessary in the buildings, they have partnered with the police departments to provide 3 SLEO IIIs in each school. The SLEOs have the same SRO training and while they do not teach in the classroom, they are armed. The district pays almost \$140,000 annually for those officers and believes this to be a more economical way of providing security. Mr. Gundersen looks forward to having a good working relationship with both the borough and the police department going forward.

The superintendent will develop and implement a student recognition program that will result in more meaningful recognition for awards, highlight premier student / staff accomplishments, and share such information with the community in an effective manner. Achieving this goal will thereby entitle him to a merit bonus of 2.5% of his annual salary for a total of \$4,837.

On September 28th there will be a security meeting with administrators, and SLEOs to develop a plan to move forward with other security measures.

Pascack Hill's turf is scheduled to be installed at the end of the football season.

Pascack Valley's power issues are still being researched.

Ms. Molinelli asked what the plays will be this year. Mr. Gundersen will find out for her.

Mr. Scher asked about the security enhancements at the front entrances. Mr. Gundersen responded that we are working towards a more cohesive plan for all the security needs which will be implemented.
