In an effort to enhance the district's ability to provide staff wellness support, the School Business Administrator will initiate a comprehensive review of deferred compensation plans offered by the District, and establish and spearhead a committee in collaboration with PVREA to eliminate underperforming providers and interview three potential providers of tax deferred retirement plans.

The Business Administrator will launch a presentation to the district employees for the purpose of educating the membership on differences between no load and loaded 403b, 457, and Roth plans and the financial impact of those differences. The business administrator will also augment this process with a minimum of two scheduled opportunities at each school for employees to enroll with providers within the current school year.

In an effort to encourage employees to become more informed with respect to their investment options, it is the business administrator's goal to have a minimum of 30 current tax deferred enrollees in attendance at the session. Achieving the goal of increasing participation among those employees who are not currently enrolled by 3% will entitle her to a merit bonus of 3.33% of her annual salary for a total of \$5,486.68.

#### 6. Superintendent of School Contract

WHEREAS, the Pascack Valley Regional High School District Board of Education (hereinafter referred to as the "Board") and P. Erik Gundersen, entered into an Employment Agreement for the term commencing July 1, 2016 and expiring June 30, 2021 (hereinafter referred to as the "Present Employment Agreement");

WHEREAS, the Board and the Superintendent desire to rescind the Present Employment Agreement prior to its conclusion and enter into a new Employment Agreement for a term commencing July 1, 2017 and expiring June 30, 2022 (hereinafter referred to as the "Succeeding Employment Agreement"); and

WHEREAS, this Employment Agreement has been submitted to and approved by the Executive County Superintendent according to standards adopted by the Commissioner of Education pursuant to N.J.S.A. 18A:7-8(j);

**NOW, THEREFORE, BE IT RESOLVED** that the Board hereby rescinds the Present Employment Agreement of P. Erik Gundersen;

**BE IT FURTHER RESOLVED** that the Board hereby appoints P. Erik Gundersen as the Superintendent of Schools for the Pascack Valley Regional High School District for the period beginning on July 1, 2017 and expiring on June 30, 2022 in accordance with the terms of the Succeeding Employment Agreement annexed hereto and incorporated herein by reference; and

**BE IT FURTHER RESOLVED** that the Board approves the attached <u>Succeeding</u> <u>Employment Agreement</u> with P. Erik Gundersen for the position of Superintendent of Schools for the foregoing period of appointment; and

**BE IT FURTHER RESOLVED**, that the Board hereby authorizes the Board President and School Business Administrator to execute the Succeeding Employment Agreement on behalf of the Board.
