IV. ROUTINE MATTERS

Monthly Reports

Superintendent's Report: Mr. P. Erik Gundersen

I am pleased to announce that our district implemented its third virtual day program for students on April 6 – the Friday of Spring Break. We experienced high participation rates from our students and noted that many students were engaged in their lessons on April 6 even while traveling with family. I would like to commend our staff who were present in the building that day and also commend staff who had pre-arranged vacation plans who logged in on April 6 to interact with students. It is my hope New Jersey will relax its "seat time" requirements for schools and work with schools like ours to provide a more welcoming opportunity for schools to engage students virtually for inclement weather.

Dr. Barry Bachenheimer and I attended the League of Innovative Schools Summit in Charlotte, North Carolina. During the summit, we sought out support from colleagues around the nation to learn more about how their states have opened up opportunities for virtual learning in the event of foul weather. I hope to collaborate with our new commissioner of education regarding this topic in the future.

Many of you may have heard about the successful lifesaving efforts of our SLEO III officer, Roger Caron. It was during one of his hallway patrols when a girl approached him. She was choking and he quickly reacted – as trained and performed the Heimlich maneuver on the student. This is another example of how important it is to have trained individuals –such as our SLEO III's present in our schools. I know I join all of you in thanking officer Caron.

I am wrapping up my annual meeting with the councils. On April 9 I met with the River Vale Town Council to provide them with a status report on what is taking place throughout our district. I was pleased to hear how they support our security initiatives, and they had very nice things to say about their personal experiences with the Milestones program and our guidance counseling staff. Tomorrow, I will be attending a Hillsdale Town Council meeting to provide them with the same report.

Finally, a very important note, someone who was with our district for 27 years, 26 as principal of Pascack Hills High School; Bart DiPaola, who retired in 1994, passed away this past weekend. Affectionately known as 'principal emeritus' at Pascack Hills and occasionally we would hear from students and staff members that they had received a note from Bart DiPaola congratulating them on their achievements just as he had done when he was principal. Really nice to see that someone who spent 27 years in the district to have that close bond even in retirement. He will be remembered and his impact in the district will forever live on.

WHEREAS, the Bergen County Special Services School District, referred to as the "BCSSSD" is a body corporate organized under the laws of the State of New Jersey pursuant to N.J.S.A. 18A:46-29.

WHEREAS, the LEA is required by law to provide remedial and auxiliary services to eligible students attending non-public schools within the public school district served by the LEA. N.J.S.A.18A:46-19.1, et seq. (Laws of 1977, Chapter 193); N.J.S.A. 18A:46A-1, et seq. (Laws of 1977, Chapter 192).
