# OFFICIAL PROCEEDINGS OF THE BUDGET HEARING & REGULAR MEETING OF THE BOARD OF EDUCATION, EAU CLAIRE, WISCONSIN, OCTOBER 21, 2013 PRESIDENT CRAIG PRESIDING

Following the Pledge of Allegiance, President Craig called the meeting to order at 6:00 pm. Secretary Patti Iverson confirmed that the meeting was properly noticed and was in compliance with the open meeting law.

Roll call was taken and the following commissioners were present: Craig, Cummins, Duax, Hambuch-Boyle, Johnson, Spindler and Xiong. Absent: None.

#### **UPDATE ON FINAL CHANGES IN THE 2013-2014 BUDGET**

Mr. Dan Van De Water, Executive Director of Business Services, gave an update on final changes made to the 2013-2014 budget subsequent to receiving data from the state. He noted that Governor Walker signed legislation to distribute \$100 million to school districts and the impact of that decision will be shared with school districts on October 23, 2013. The district can adopt the budget as modified and direct administration to incorporate adopted budget changes in general state aid and the general fund tax levy as a result of the new legislation.

#### PUBLIC HEARING ON THE 2013-2014 ECASD BUDGET

Mr. Van De Water shared modifications made to the approved budget as a result of certification of data from the Department of Public Instruction. When comparing the tax levy from 2012-13 to 2013-14, there was a projected decrease of 1.3%. In terms of tax rate, the equalized tax rate will be \$9.68 per \$1,000 of property value, which would be a decrease of 3.3%. Given the information that is projected to be released from the state on October 23, 2013, there would be a decrease in tax levy of 2.3% and a decrease in the tax rate of 4.4%.

President Craig asked for public comment on the 2013-14 budget. No one came forward.
