SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. An SEA must allocate at least 90 percent of its ARP ESSER grant funds to its LEAs (including charter schools that are LEAs) in the State in the same proportion that the LEAs received under part A of title I of the ESEA in Fiscal Year 2020, as required by section 2001(d)(1) of the ARP Act; and section 2001(e) of the ARP Act prescribes certain mandatory and permissive uses of LEAs' funds. The District developed a plan based on feedback and recommendations from staff, district leadership, Board of Education, and the general public. The general public was provided an opportunity to make recommendations at a Public Comment period, which was held during the July 14, 2021 Board of Education meeting. An additional meeting was held on December 13, 2021 via Zoom targeting stakeholders who represent the interests of children with disabilities, English language learners, children experiencing homelessness, and children in foster care. All other constituency groups (tribes, civil rights organizations, disability rights organizations, stakeholders representing the needs of migratory students, and children who are incarcerated are not applicable in our LEA. An agenda and information regarding the use of funds was distributed and presented. Feedback was verbally given to the district from the attendees, which was considered if an allowable expense. Moving forwards, the district is planning to keep the public apprised at monthly Board of Education meetings, newsletters and other communications as appropriate. The district will encourage continuous feedback from the stakeholders in these communications and meetings. In addition, the district sent out information to all stakeholders including a link to submit any input and comments. This information was also made available in hard copy in each building for anyone without internet access.

Funds will be used to implement education strategies, focusing on math, reading, student wellness, and student mental health.

- 4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

The district will utilize a variety of methods to identify student needs and continuously monitor student progress. This includes student performance on NYS Assessments for grades 3-8, NYS Regents Exams, locally-administered exams and diagnostic testing such as DIBELS and DRA. Student report cards and progress reports will be monitored by administration and/or school counselors to gauge student progress during the course of the school year. IEP progress reports will also be another piece of data we will utilize. The data generated by these methods will be a combination of quarterly grades, teacher comments on report cards and progress reports, test scores from unit exams, benchmark assessments, and formative assessments such as quizzes and classwork. Diagnostic testing data will include student scores and score ranges that establish a student's current skill level. Interventions such as our summer school program, additional AIS services, after school tutoring program, and the utilization of such programs including Foundations, Envisions, and STAR will be implemented to address any deficiencies in student proficiency. After the necessary interventions have been implemented, the student's scores will be compared to previous ones to monitor for effectiveness.

- 5. The district has implemented a summer school program for elementary and middle-level students who are identified as academically at risk due to lack of progress or achievement the previous school year. The high school summer school program has been implemented as a credit recovery program in order to keep students on track to graduate on time. Additional after school and summer programs will include an after school tutoring program focused on content-based strategies and developing skills, a health and wellness initiative offering additional intramural sports for all students, a summer learning enrichment program, and an art and music enrichment camp. Our District selected evidenced based programs such as Foundations K-2, Savvas Reading Street K-5, Savvas Envisions Math K-5, and Credit Recovery Programs to provide instruction for our students. Each program was selected based on its rigor, alignment to Common Core and Next Generation Standards, technology integration, home to school connections, core instructional materials, and evidence based practices to support and teach our struggling students. These programs are aligned to our grade level curriculum maps and NYS Learning Standards.

The district will utilize these funds to continue our district initiative to provide Chromebooks to all students K-12 as well as "hotspots" to accommodate those with inadequate or no internet access in their homes.

The district's interventions to address the academic impact of lost instructional time, the academic, social, emotional and mental health needs of students from low-income families will include an after-school tutoring program that will focus on skill-building in reading and mathematics, providing technology such as Chromebooks and "hotspots", and an additional social worker to support social-emotional learning and mental health. Each of these interventions will be supervised and evaluated by an on-site administrator. If any deficiencies are noted, adjustments will be made to ensure that these interventions firmly support the needs of these students.

The district's interventions to address the academic impact of lost instructional time, the academic, social, emotional and mental health needs of students of color will include an Art and Music Enrichment Camp that will provide programming not often available to this subgroup of students providing technology such as Chromebooks and "hotspots", and an additional social worker to support social-emotional learning and mental health. Each of these interventions will be supervised and evaluated by an on-site administrator. If any deficiencies are noted, adjustments will be made to ensure that these interventions firmly support the needs of these students.

The district's interventions to address the academic impact of lost instructional time, the academic, social, emotional and mental health needs of English Language Learners will include a summer enrichment program and an after-school tutoring program targeted to providing continuing skill development in reading and language, as well as an additional AIS teacher to support English language acquisition, and an additional social worker to support the social-emotional needs of this subgroup of students. Each of these interventions will be supervised and evaluated by an on-site administrator. If any deficiencies are noted, adjustments will be made to ensure that these interventions firmly support the needs of these students.

The district's interventions to address the academic impact of lost instructional time, the academic, social, emotional and mental health needs of students with disabilities will include an after-school tutoring program and summer enrichment program that will focus on skill-building in reading and mathematics, an additional social worker to support social-emotional learning, mental health needs, and any IEP counseling, and an additional AIS teacher to provide supplemental instruction to ensure this subgroup of students acquire the skills and knowledge necessary to be successful in all academic areas. Each of these interventions will be supervised and evaluated by an on-site administrator. If any deficiencies are noted, adjustments will be made to ensure that these interventions firmly support the needs of these students.
