The district is working with the Vendor Daktronics to finalize the quote to replace the Higley HS scoreboard. The quote has been added in Board Docs.

In the board agenda for May 8, action item 8.6 contains the resolution document calling for a bond. On the sample ballot, page A-1, there are two bullet points needing clarification:

- Constructing and/or purchasing school buildings
- Acquiring by purchase or lease school lots

Are we planning on constructing or purchasing new buildings? Are we also planning on purchasing or leasing school lots?

The statements on the resolution are general ballot language. If there were a need for constructing/purchasing/leasing any new buildings or lots, we would still be required to follow the process to bring such a request before the board.

In the board agenda for May 8, action item 8.7, please see highlighted section below. What was the purpose of evaluating removing the high schools from the National School Lunch Program?

The current contract for Higley Unified Food Service Management Company (FSMC) is up for renewal for FY2025 as the district is currently in year five of five of the contract. The Purchasing department organized a Request for Proposal (RFP) with guidance from the Arizona Department of Education Health and Nutrition Services Department. One item the district evaluated was potentially removing the high schools from the National School Lunch and Breakfast Program (NSLP). Potential bidders were asked to provide two different proposals one with all school on the NSLP and one with the high schools off the program.

The purpose of evaluating the option to remove the high schools from the National School Lunch Program was to allow for a more flexible menu to provide students with additional choices beyond the limits set by the NSLP.
