# **Leadership Thurston County – Summer Partnership**

Leadership Thurston County (LTC) was founded in 1992 with the purpose of developing community leaders by acquiring knowledge, building relationships, and enhancing leadership skills. Alisha Blain-Warner, Program Director of Leadership Thurston County has been working on a project to create a community immersion program for area youth. In an effort to reach students from various school districts, LTC will be partnering with New Market Skills Center to offer an Industry Day of Enrichment to summer school students. Each summer school program will include a day where students can visit worksites, engage with guest speakers, or attend industry panels aligned with their career pathway. This opportunity, sponsored by Thurston County businesses, will be at no cost to New Market or students and will include lunch and transportation. Ms. Maliska shared that Shelton School District offers a similar program for their freshman students and would be available to discuss their successes and pitfalls. Chair Bogatin asked to be informed of the dates/times to share with councilmembers for potential board participation.

The Culinary Arts program provided lunch for the councilmembers. The menu choices were described by Chef Joel Shumate and the following Culinary Arts students: Kalvyn Hudson - Shelton High School, Dylan Stallings - Black Hills High School, & Anna Roberts – Cascadia High School.

#### Fall Program Advisory Dinner and Meetings – October 12, 2023

New Market Skills Center hosted a kick-off dinner for the New Market and Tumwater School District Fall Advisory Meetings.

Keynote speaker Michael Cade, Executive Director of Thurston County Economic Development Council, presented regional economic data. It highlighted the importance of advisory member contributions in keeping our programs up to industry standards.

#### Marine Corps Bootcamp Graduate - October 13, 2023 - Navy National Defense Cadet Corps

Mr. Ishler shared the success story of a 2023 NMHS graduate, who started the NNDCC program last year with the odds against him. Now he visits the class in full military dress to speak to students about his path.

## Career & College Fair - November 14, 2023

New Market's first Career and College Fair was a huge success. Laurel Ponzoha, Student Support Specialist, coordinated 36 vendors representing careers aligned with New Market programs. Students practiced their networking skills amongst the representatives and the room was a buzz the entire time. Additional vendors have reached out to Ms. Ponzoha to participate next year.

# Bearzaar – Olympia High School – November 18, 2023 – Culinary Arts

For the 2<sup>nd</sup> year, our Culinary Arts program provided food and desserts at the Olympia Bearzaar Event. Olympia CTE Director, Paula Perryman, noted the valuable partnership between the OHS and NMSC culinary departments.

# Student of the Quarter - November 20, 2023

Mr. Ishler congratulated the students who were awarded Student of the Quarter. The first quarter recipients represented various sending high schools.

#### Students' Blood Drive - Bloodworks Northwest - November 22, 2023

Our nursing and medical programs, supported by our Worksite Learning Coordinator, held a blood drive through Bloodworks Northwest. Twenty units of blood were collected from nineteen first time donors.

#### **Enrollment Reports**

By District

Mr. Ishler noted the current program headcount is 770, with 13 students enrolled in the worksite learning program. Enrollment remains high with 90% of seats filled.

## Student Headcount by Program

This report breaks down the headcount and FTE numbers by district and high school. Councilmember Clemens asked if there was a column for each district's commitment numbers. Mr. Ishler will add district slot assignments to future reports.

## Headcount Ethnicity Report

Councilmember Murphy appreciates the net numbers provided on the Ethnicity Report, but would like to see Race, Ethnicity, and Sped proportions by district served. He also inquired about adding free/reduced lunch numbers per district. Mr. Ishler indicated

that we do not participate in the free/reduced program, and do not currently collect that data from districts. Councilmember Clemens mentioned that each family would need to give permission to their home school to share free/reduced lunch data to New Market Skills Center.

# **Financial Report**

Mr. Ishler provided an update on the financial report. Shelton School District representative Gretchen Maliska questioned why funding was so low when enrollment is up. Mr. Ishler replied that until each year January, apportionment is based on budgeted rather than actual FTE. In the January apportionment, any underpayment is corrected by OSPI. For this particular end-of-month report however, the November apportionment was also not reflected as it had not been yet transferred from TSD to the NMSC general fund.

Last meeting, Mr. Ishler was asked how much a certification exam cost. In our Professional Medical Careers program, the newly approved Home Health Care Aid certification exam is \$137 and Department of Health application fee is \$100. The Nursing Assistant Certification exam is \$155 and Department of Health application fee is \$86. Chair Bogatin asked if New Market covers the cost. Mr. Ishler stated that we try to cover what we can with grants, but we do not always have funding available.

## **TOPICS REQUESTED**

## **Culinary Arts - Program Tour**

The council members toured the Culinary Arts classroom, kitchen, and deli. Chair Bogatin appreciated the opportunity to see students in action. A new program visit will be scheduled for each meeting.

#### **Open Doors Discussion**

In previous meetings, Councilmember Clemens and Shelton School District representative Gretchen Maliska inquired about Open Doors. Mr. Ishler asked for clarification on the topic. Councilmember Clemens remembers wanting to capture the kids who never came back after COVID and having opportunities to fill the gaps in services. Mr. Ishler reached out to Andrew McCabe, Gravity Coordinator, who noted Gravity programs are currently located in Yelm, Lacey, Olympia, Shelton, and Lewis County. Tumwater currently does not have a significant demand for an additional location. Students enrolled in Gravity can also be enrolled in the Skills Center. Councilmember Clemens commented that Gravity is the right choice for some, but for others earning a diploma or certification could be a more impactful choice. Mr. Ishler provided information on New Market High School (NMHS), an ALE program located on the New Market campus. NMHS may be filling this gap, as its purpose is to provide opportunities for students to earn core academic credits and a high school diploma while concurrently enrolled in a CTE program that aligns with their career pathway. NMHS students receive individualized learning and support and are often students who don't find success in a comprehensive high school setting. NMHS is under the Tumwater School District umbrella, but does accept students from all districts with the proper transfer approval.

In addition, North Thurston Public Schools CTE Director Brad Hooper is working with Tumwater School District's CTE Director Brian Hardcastle and the United Way Financial Stability Task Force to create a post high school training program. This task force is a collaboration of United Way, SPSCC, PacMtn WorkSource, Masters Builders, and BIAW representatives and formed to meet community needs and provide training for living wage jobs. The highest need for skilled labor is in the carpentry field. The task force reached out to New Market to provide the facility for the planned construction training.

#### **GRANTS RECEIVED**

#### Fix Auto Grant through the I-CAR Education Foundation - Collision Repair Technology \$12,720

The grant provided \$5,000 towards equipment/paint supplies, \$1,000 for curriculum, and \$6,720 for student testing fees.
