President Jay Wood called the meeting to order at 7:00 p.m.

Agenda Discussion/Approval

Agenda Changes: John Bash shared there were no changes to the agenda.

Approval of Minutes

Rita Luce/Melissa Beard, M/S to approve the minutes from the October 22, 2018 Special Meeting and the October 25, 2018 Regular Meeting. The motion passed unanimously.

Special Recognition

- Women's Suffrage Historical Marker at LRE: Mel Murray introduced Diane Smith. Diane is a part of Daughters of the American Colonists (DAC) shared some information about the eight women who voted in Littlerock in 1870, which was 50 years before the ratification of the 19th Amendment, which gave all women in the US the right to vote. They propose to place a marker on the grounds of Littlerock Elementary and in 2020 will have a ceremony as well as a reenactment of the event. They are also hoping to have an essay and an art project, with a monetary prize, that is attached to this event. They are also hoping to find living descendants of these women. Melissa Beard/Janine Ward, M/S installation of a historical marker at Littlerock Elementary in 2020. The motion passed unanimously.
- <u>TSD History Committee</u>: Jay Wood introduced the committee members and shared a bit about the process of researching and writing the book. Don Trosper shared that standing in the board room was interesting because this is exactly where he went to middle school! He talked about the history of the district and his family history in the area. Janine presented certificates to the committee members and John let the committee know that as a token of appreciation, the District is giving TSD reusable shopping bags and copies of the book so they can help to get them out into the community.

Student Introductions/Reports

<u>Eleanor Kim-BHHS</u>: She introduced herself, sharing that she loves music and plays volleyball. She applied to be a member of the board was a perfect opportunity to make changes at her school. The answer to the question: foreign exchange students commented on school spirit, how teachers truly care about students. However, some people were not inclusive but that is not a true representation of the school. Freshman are enjoying high school but had some comments about PAC time.

- Nalani Matautia-THS: She has been on the dance team for four years and been the captain for the last two years. She has two jobs. The reason why she wanted to be a student rep was because she felt like her voice was not heard and didn't know how to make change. She hopes to be a voice for others who feel voiceless. She interviewed freshman who are excited and involved. One of the seniors, who came after school started, felt a first he wasn't welcome but that has changed and he feels included. She reviewed a few things going on around the school with the Veteran's Day assembly being held tomorrow and the equity team that meets once a month.
- Aryana Warner-SO: She has quite an interest in government, which is why she wanted to be a student rep. All new students go into a class at SO and the students have an ever-growing fondness of Secondary. Often times they are quite reserved when coming in as there is not a lot of information about the school so there is a lot of unknown and they are often coming from a home environment that is not very supportive. The classes are very small and people like that and there is a lot of independence be a student there. She works to support herself, as do many other students there, so the shortened day helps her in her personal life. The students love their teachers and Debbie Center and she didn't hear a single complaint from any student.

Business/Financial Update:

Financial Update: Jim Brittain presented on this topic. He began by discussing enrollment, which is down from last year. The numbers he presented include all students (Running Start, New Market, Open Door, etc.) He reviewed apportionment/levy and other revenue sources, which all impact the General Fund balance. He talked a little about the Budget Audit Committee and the fact that two of the members are CPAs who will help to scrutinize our budget. He provided a list of items that the voters used to approve the levy that the Board is going to have to look at and make some tough decisions about how the District will proceed. There was discussion around the four year forecast and how SEBB and pensions may negatively affect the district. Kim Reykdal encouraged everyone to continue to make their voices heard and to channel the energy toward the legislature.

Superintendent's Report

Superintendent's Remarks: John Bash presented on this topic. He began by talking about Walk & Roll at Tumwater Hill. The Mayor as well as the Chief of Police and one of the District's SROs joined him, teachers and students as they walked through the fog to school! Intercity Transit is launching a new bicycle program, with their target audience being middle and high school students. They will be working with TSD staff to identify students who might benefit. He shared a budget planning calendar, which includes community forums, a budget audit committee, a budget development survey and presentations to the Board and some decision making that will need to take place. The request is that the Board review this calendar and get back to him if they have thoughts, reminding them that the clock is ticking and we need to

get started as there is a budget adoption date that the District does not have control over. He presented some questions/topics that the student reps could address and present at each board meeting throughout the year with the December topic being Community Service. He reviewed the District/Board legislative priorities with Rita asking to have the prototypical school model being reviewed to reflect what truly happens in a school added as a priority. There was some discussion around SEBB and how it seems as though it will negatively impact the state, employees and employers, in its current iteration. John is asking the Board for feedback on the format of the document and will reach out to them all if he does not hear back. He wants to ensure that it is effective and representative of what the Board wants.

Board Member Comments

- Kim Reykdal: She talked a bit about board members from around the region and legislators. She was able to enjoy her daughter's student led conference at Tumwater Middle School and really appreciates the process and the school shifting to allow the students to present and share what they are learning.
- <u>Rita Luce</u>: She and Jay have been visiting schools, which she really enjoys. They went to Littlerock this week and were able to watch the pick-up time where a para or the principal opened every single car door!
- Janine Ward: She has been in California for work but enjoyed the WASA event she attended last night.
- Melissa Beard: She talked about the King 5 story with Sidney Reid and is so impressed by some of the things that students in our schools are learning.

The regular meeting recessed at 9:02pm President Jay Wood recessed the regular meeting and stated the Board would adjourned into Executive Session, which would last approximately 45 minutes. The Executive Session began at ended at 9:45pm. The regular meeting reconvened at 9:46pm. With no further business coming before the Board, the regular meeting adjourned at 9:46pm.
