# Superintendent Process & Goals

# 1. Superintendent Evaluation Tool

In 2013 the Washington State School Director' Association (WSSDA) the Washington Association of School Administrators (WASA) partnered to produce and co-endorse a superintendent evaluation process. The first step in the evaluation process is to mutually agree and adopt performance standards. Included in the board packet is a copy of the Washington Standards-Based Superintendent Evaluation (WSBSE) that includes six performance standards. Each standard has one or two strands and themes to guide the evaluation process, however the standards are rated overall on a scale of Unsatisfactory to Distinguished.

Standard 1: Visionary Leadership Standard 2: Instructional Leadership Standard 3: Effective Management Standard 4: Inclusive Practice Standard 5: Ethical Leadership Standard 6: Socio-Political Context

#### **Action Requested:**

Affirm the WSSDA/WASA Washington Standards-Based Superintendent Evaluation tool as presented.

# 2. Superintendent Goals

Boards and superintendents have the option to narrow and adopt a limited scope of standards to be used in the evaluation process. These goals should be based on the superintendent's previous evaluation and/or the district's current strategic initiatives or goals. Ideally, these goals should be developed collaboratively. A draft of proposed superintendent goals will be presented.

#### **Action Requested:**

Approve and adopt, in regular session, superintendent goals for 2023-2024.

### Motion Requested:

"I move to adopt the superintendent goals as presented (or as amended)."

## 3. Timeline

WSSDA has developed a recommended timeline for the superintendent evaluation process.

### 2023-2024 Proposed Timeline

August 10, 2023 Work Session: Review Evaluation tool, superintendent goals, and evaluation timeline.

August 24, 2023: Approve Evaluation Tool, Superintendent Goals, and Evaluation Timeline in consent agenda.

**January 11, 2024 Executive Session:** Check-in to give the superintendent an opportunity to provide information related to the goals and standards, and for the board to ask questions about progress and provide additional guidance and support.

March 14, 2024 Executive Session: Superintendent self-evaluation is presented to the board. The board will also have the opportunity to ask questions about the goals and objectives of the evaluation.

**April 11, 2024 Executive Session:** The board meets to complete the evaluation without the superintendent. When the evaluation is completed, the board will meet with the superintendent to review evaluation results.

April 25, 2024 Regular Session: Generally, the board crafts a short narrative statement about the evaluation to be shared and adopted in regular session.

### 2024-2025 Proposed Timeline

April / May: Pre-evaluation: Adopt standards, goals, etc.

June, 2024 - January, 2025: Schedule board/superintendent check-ins.

March, 2025: Superintendent self-evaluation

April, 2025: Evaluation review
