**Cosmetology School Program Overview:** In our cosmetology class, you'll dive into the fundamentals of hair design, and also explore the exciting world of Esthetics and nail services. This is a 1600 hour program. After completing two full school years and two summers, you will leave with the knowledge and skills to take the Washington state cosmetology test. Get ready to unleash your creativity and become a well-rounded beauty professional!

### Program Objectives and Units:

- Professionalism: Learn about salon etiquette, customer service, and maintaining a clean and organized work environment.
- Hair cutting and coloring: Gain skills in haircutting techniques, hair color application, and creating different styles and looks.
- Manicures and pedicures: Learn how to provide nail care, perform manicures and pedicures, and apply nail polish and nail art.
- Makeup, Hair removal and facials: Acquire knowledge in Makeup Application, hair removal techniques, and learn how to perform facials to improve skin health and appearance.

### Program Supplies & Fees:

New Market school of Cosmetology kit and books will be provided for in class use only. Students are responsible for their own kits and are required to uphold the Washington state standard by keeping kits clean.
