<input type="checkbox"/>	<b>Tray Only</b> – A tray meal is a maximum of 5 components (meat/meat alternate, fruit, vegetable, grain, and milk). Any tray is \$1.60. By selecting the Tray Only option the student account will be restricted from purchasing anything except the tray meal. We will automatically set the breakfast spending limit to \$0.85 and the lunch spending limit to \$1.60.
<input type="checkbox"/>	<p><b>Tray + A La Carte Limit</b> – All purchases that are not part of the tray meal are considered a la carte. Select this option if you want your student to choose the tray meal every day but would also like to allow a la carte purchases.</p> <p>Daily a la carte spending limit _____</p> <p>A la carte purchases one day per week _____ (please specify day)</p>
