

# **Safety and Security Update**

Fort Worth ISD Board of Education Meeting Tuesday, August 22, 2023 5:30 p.m.

### **Armed Security Officer Requirement**

- New State Mandate House Bill 3 (Effective September 2023)
- Requires school districts to have at least one armed officer on every campus.
- A good cause exception from compliance may be claimed due to availability of funding or personnel.
- If a good cause exception is claimed and approved by the district's school board, an alternative standard must be developed that may include providing a marshal, trained employee or trained contractor that is authorized to carry a handgun on school premises to act as a security officer.
- Districts must maintain implementation documentation including good cause exception documentation.
- The mandate does not outline penalties for noncompliance.

#### Armed Security Options ADDITIONAL GUIDANCE COMING SOON

#### New August

School Based Law Enforcement
(ISD PD/SRO/MOU)
TEC, Section §37.081

To provide a law enforcement / security presence on campuses to detect, deter, and prevent criminal activity.

Requires all the necessary trainings, certifications, and commission as a licensed peace officers.

These officers cannot be assigned administrative or routine disciplinary duties. COSTS: \$75K – 100K Annually

**CURRENT PLAN** 

School Marshal TEC, Section §37.0811 (Good Cause Exception Req.)

Certification allowing school staff to possess and carry a firearm in the absence of law enforcement.

Training required: 80 hours, including the following topics -

- 1. Physical security
- 2. Improving campus security
- 3. Use of force
- 4. Active shooter response
- 5. Weapon proficiency
  - COSTS: \$5K \$15K Annually

Guardian Option Government Code, Section §411.1901 (Good Cause Exception Req.)

To provide school communities with an armed self defense option prior to the arrival of law enforcement in the event of an active shooter.

Training Required:

16 hours, including the following topics -

- 1. Crime prevention and deterrence
- 2. Mental preparedness
- 3. Use of force
- 4. Interaction with law enforcement
- 5. Recovery after an event
  - COSTS: \$5K \$15K Annually

### **Texas Education Agency Guidance**

- According to TEA officials we will be provided with a reasonable time period to become compliant beyond September 1, 2023.
- TEA has announced that it will provide guidance on HB 3 on August 24th, to be followed by an Armed Security Webinar on September 13th.
- Districts are encouraged to pay close attention to TEA's guidance and webinars.

### **Compliance Plan Development**

- Review of current School Resource Officer (SRO) assignments to determine adjustments that can be made to cover more schools.
- Needs Assessment: Create a breakdown of schools that need SROs.
- Analysis of violent crime rate data to identify high need areas.
- Develop a plan for compliance based on campus needs and the availability of funding and personnel.

#### HB 3: School Safety

- Establishes the Office of School Safety and Security in TEA to working in coordination with the Texas School Safety Center and with regional education service centers to provide ongoing support and oversight of LEA safety practices
- Increased the annual school safety allotment in the FSP: \$15k per campus plus \$10 per ADA
- Requires district employees who regularly interact with students to complete an evidencebased mental health training program.
- Requires districts adopt a policy requiring at least one person acting as an armed security officer be present during regular school hours at each campus.
- Clarifies required data sharing & confidentiality obligations related to student safety records

### Fort Worth ISD Compliance Plan

The following actions are recommended for the 2023-2024 school year, to establish our commitment to become compliant:

- Claim a good cause exception to allow time for development of an alternative standard for compliance.
- Request additional SROs from the Fort Worth and Benbrook Police Departments for this school year and the next two school years.
- Maximize our current SROs by assigning them to an additional nine schools that had not previously been covered by an SRO.
- Attempt to hire Off Duty Peace Officers to serve as SROs.
- Assign SROs to cover multiple schools.
- Continue to research alternative methods to reach full compliance.

#### **Maximize Usage of Current SROs**

#### **SRO Assignment Adjustments**

Nine schools will be assigned an SRO that previously did not have an Officer, which is accomplished by assigning an SRO from a nearby High School with two SROs, that has a student enrollment of less than 1,500.

Adjustments will be made as needed based on Fall PEIMS 2023-2024 student enrollment.

#### **Clear Expectations**

To establish clear communication and expectations we have clarified our meaning of the word <u>Assigned</u>.

**ASSIGNED:** A School Resource Officer (SRO) will have a specific campus as their primary duty location. They will establish clear communication protocols with school administration and develop a strong working relationship. The Officer will make every effort to be visible and present at critical portions of the day to include school opening, lunch, and closing.


The latest violent crime data is reviewed frequently and used identify and monitor schools located in high need areas of the city.

#### **Intruder Detection Audits**



During the 88<sup>th</sup> legislative session, HB 3 passed which shifts the Intruder Detection Audit process to TEA

Changes are taking place to streamline the process and make it more effectual

#### The IDA phases will remain the same

- Phase 1 Attempt entry through three random exterior doors
- Phase 2 Verify weekly door sweep logs
- Phase 3 Perform campus exterior door sweep with a campus leader
- Phase 4 Check interior doors if the district has a local policy in place.

#### Tentatively set to start late September







Exterior doors, exterior classroom doors, and portable doors should operate as intended, are required to remain closed, locked, and latched and allow for emergency egress from the inside (while remaining locked).



Windowed doors on the ground level or windows that are adjacent to or near a door and are large enough to allow someone to enter if broken must be reinforced with entry-resistant film unless within a secured area.



Exterior door sweeps must be conducted weekly to certify that all doors are properly closed, locked, and latched.



The school system must perform maintenance checks twice annually to ensure that the facility components within the rule function properly and as intended.



Disclaimer: Fencing not required but is offered to provide some operational flexibilities.

### **Avoiding Dangerous Habits**

We must remain vigilant in avoiding dangerous habits or customs that could potentially create unsafe conditions such as:

- propping doors open
- utilizing security staff for non-security tasks
- delays in reporting safety equipment problems
- failure to complete safety drills
