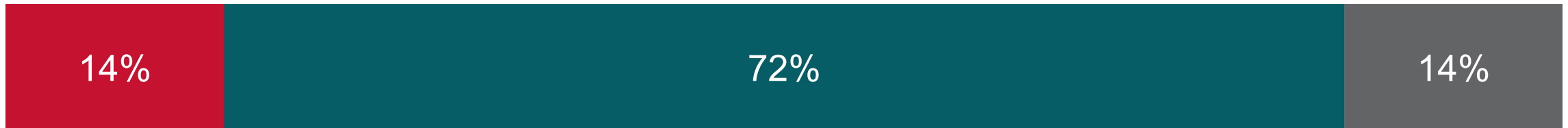
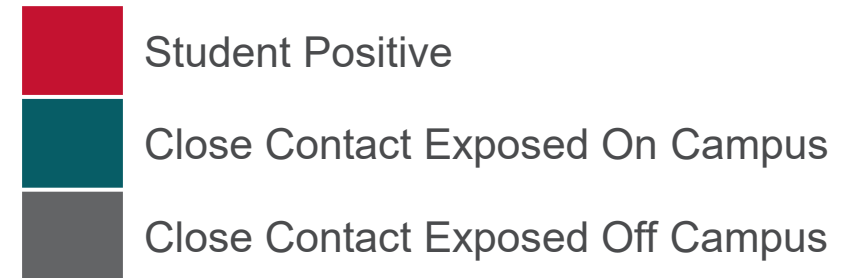

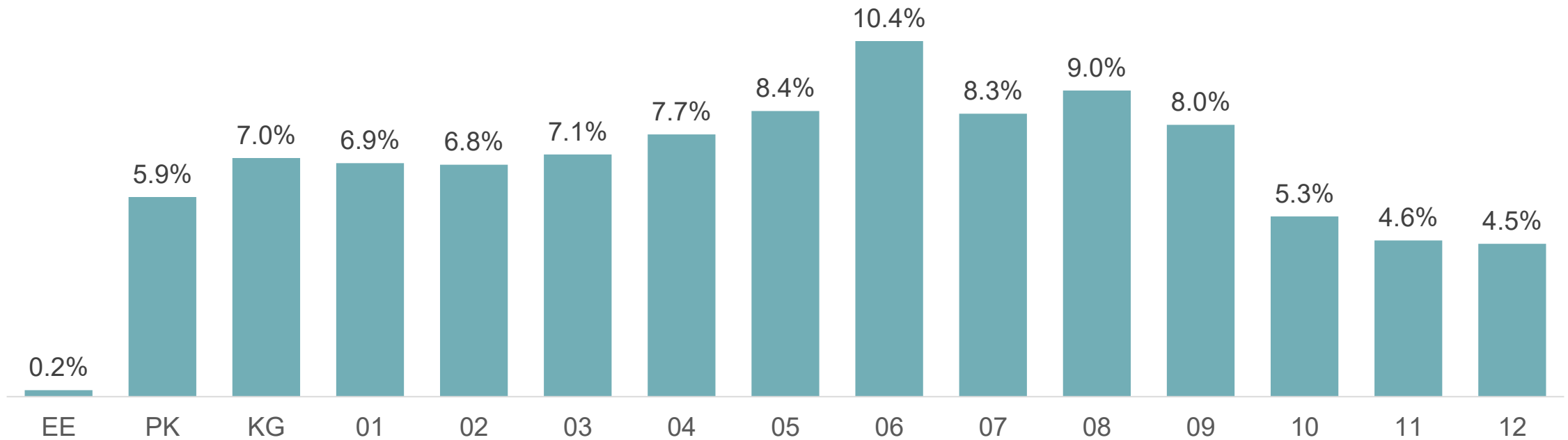
Student COVID-19 Data from August 16 to September 10

Student Enrollment Breakdown by Racial Group

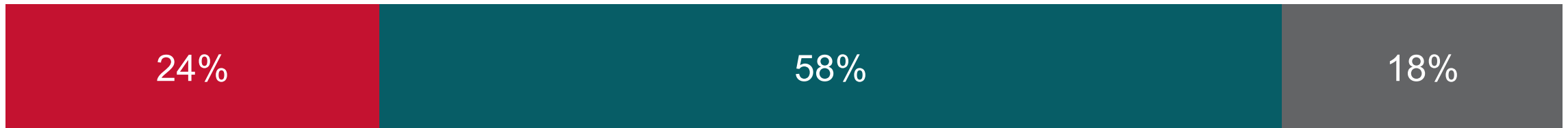
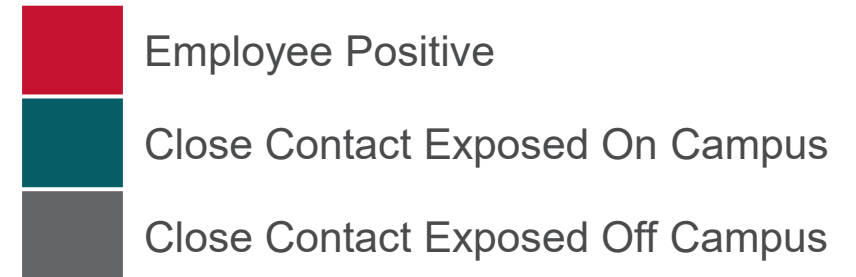

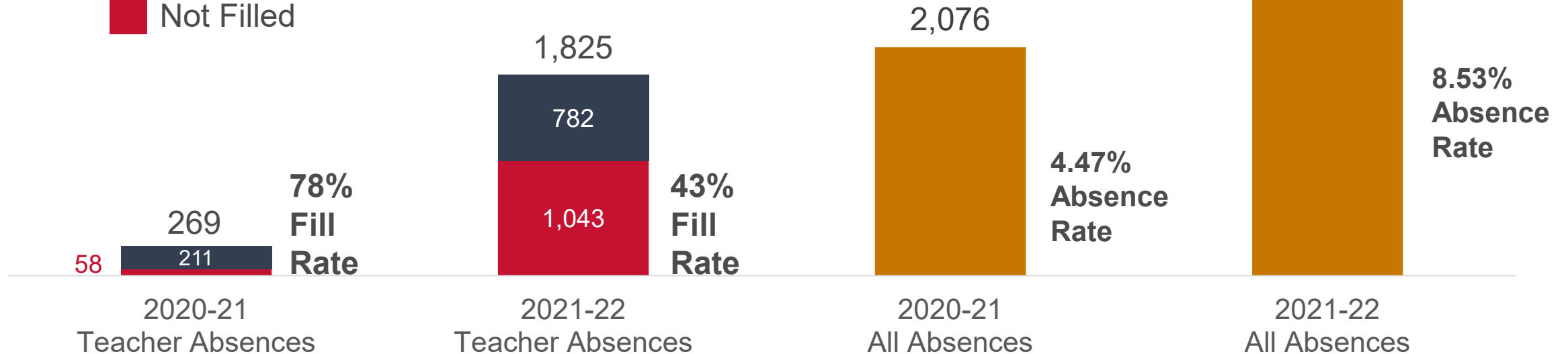

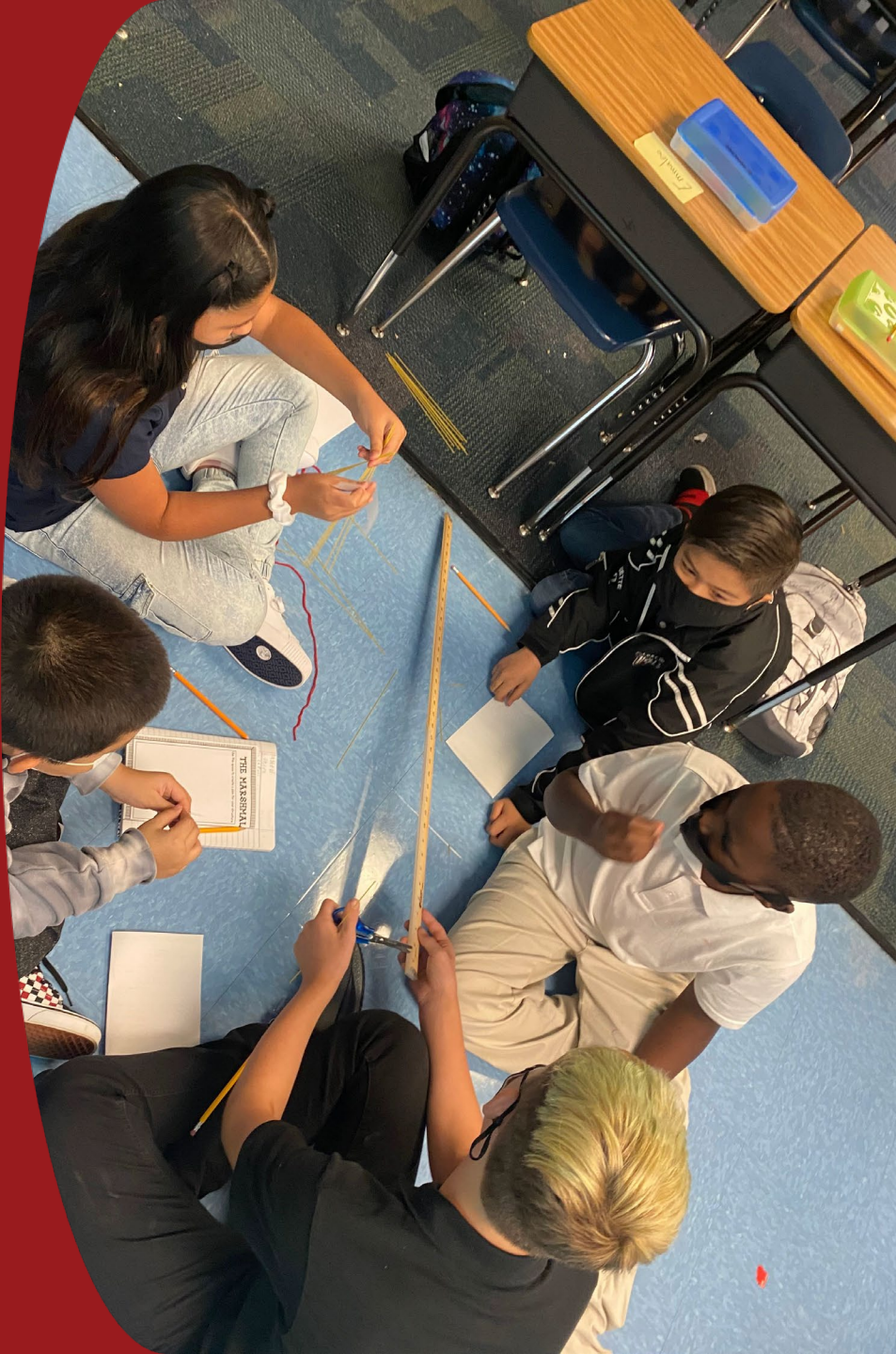

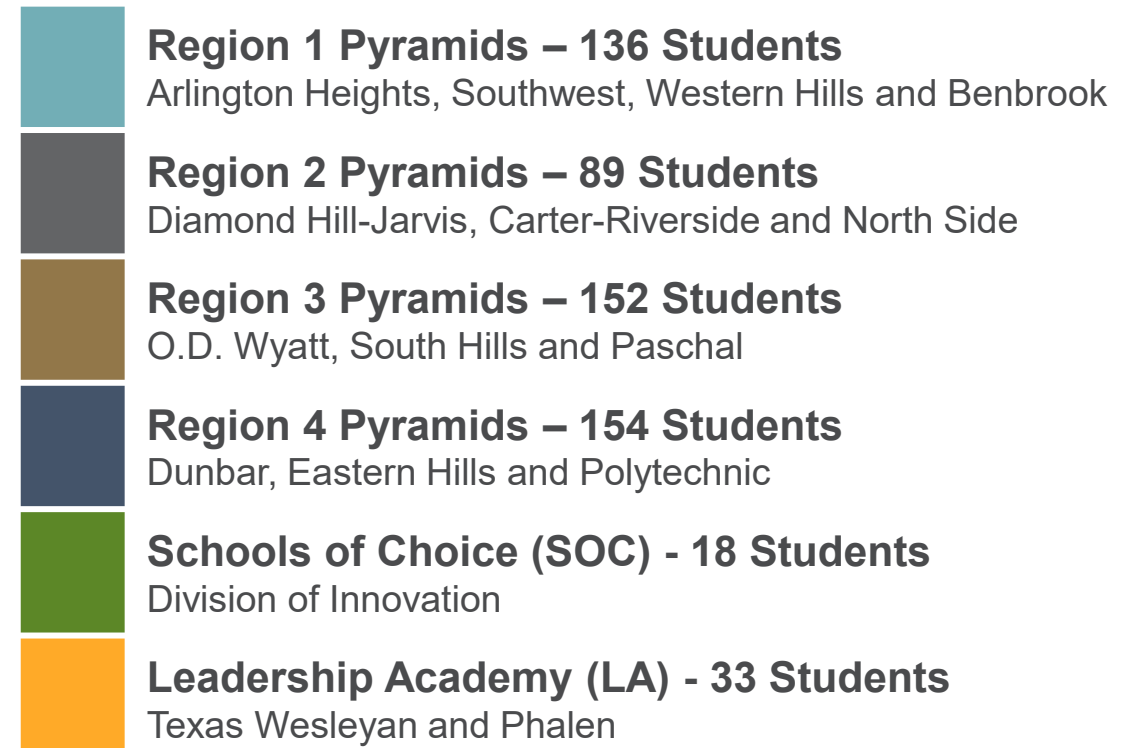
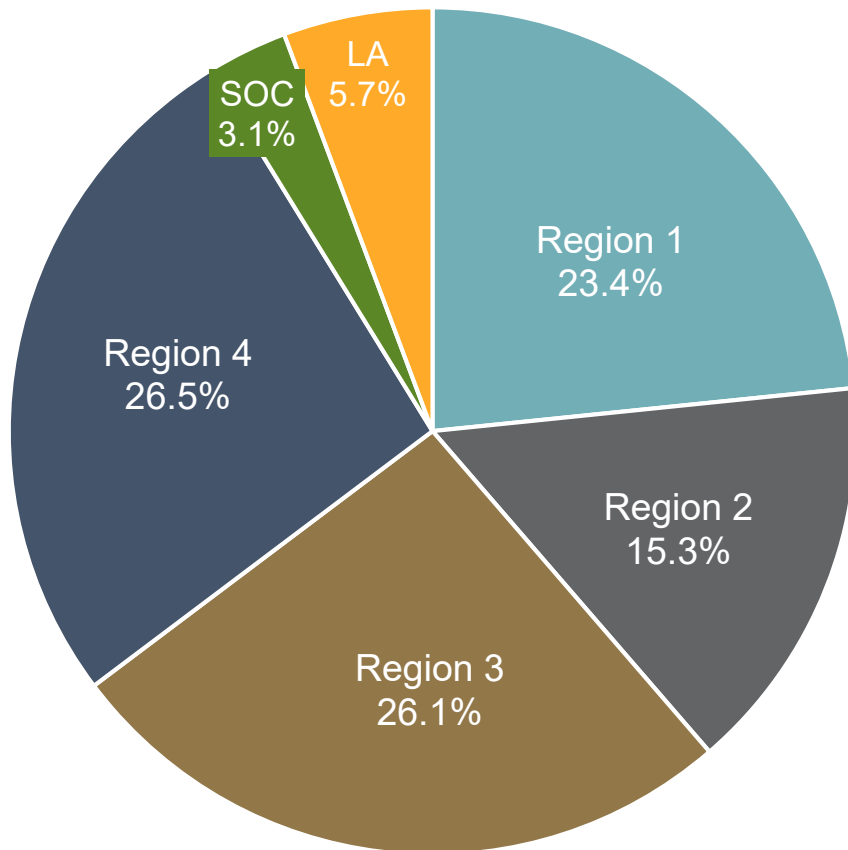

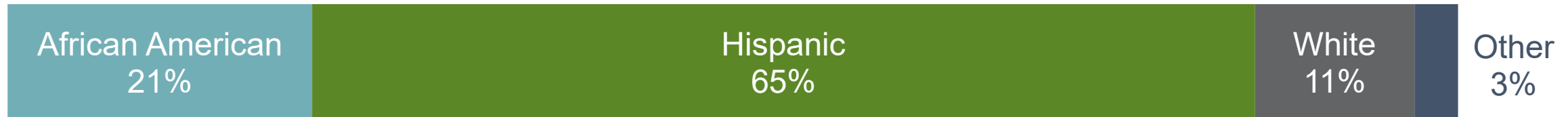

Virtual Learning Funding Update

Senate Bill 15 (SB 15) Funding Requirements

- ✓ capped at 10% of all enrolled students
- ✓ overall district-wide performance rating of C or higher
- ✓ at least one STAAR-assessed grade level offered for remote learning
- ✓ remote learning may not be the sole option offered to families (must keep in-person options)
- ✓ give assessments in the same manner for both remote and on campus students
- ✓ ability to participate in any District or UIL extracurricular activity in the same manner as other students
- ✓ meet the needs of students with disabilities and English learners who are enrolled in a remote program

Students: If a student was remote at least 50% of last year then they must have passed STAAR, had at least 90% attendance, and passed all foundation courses in order to count towards ADA for funding.

Teachers: District must provide professional learning on virtual instruction, not be coerced to teach virtual, and not be required to teach both in-person and remote students in the same class period, at the same time.

Saturday Learning Quest

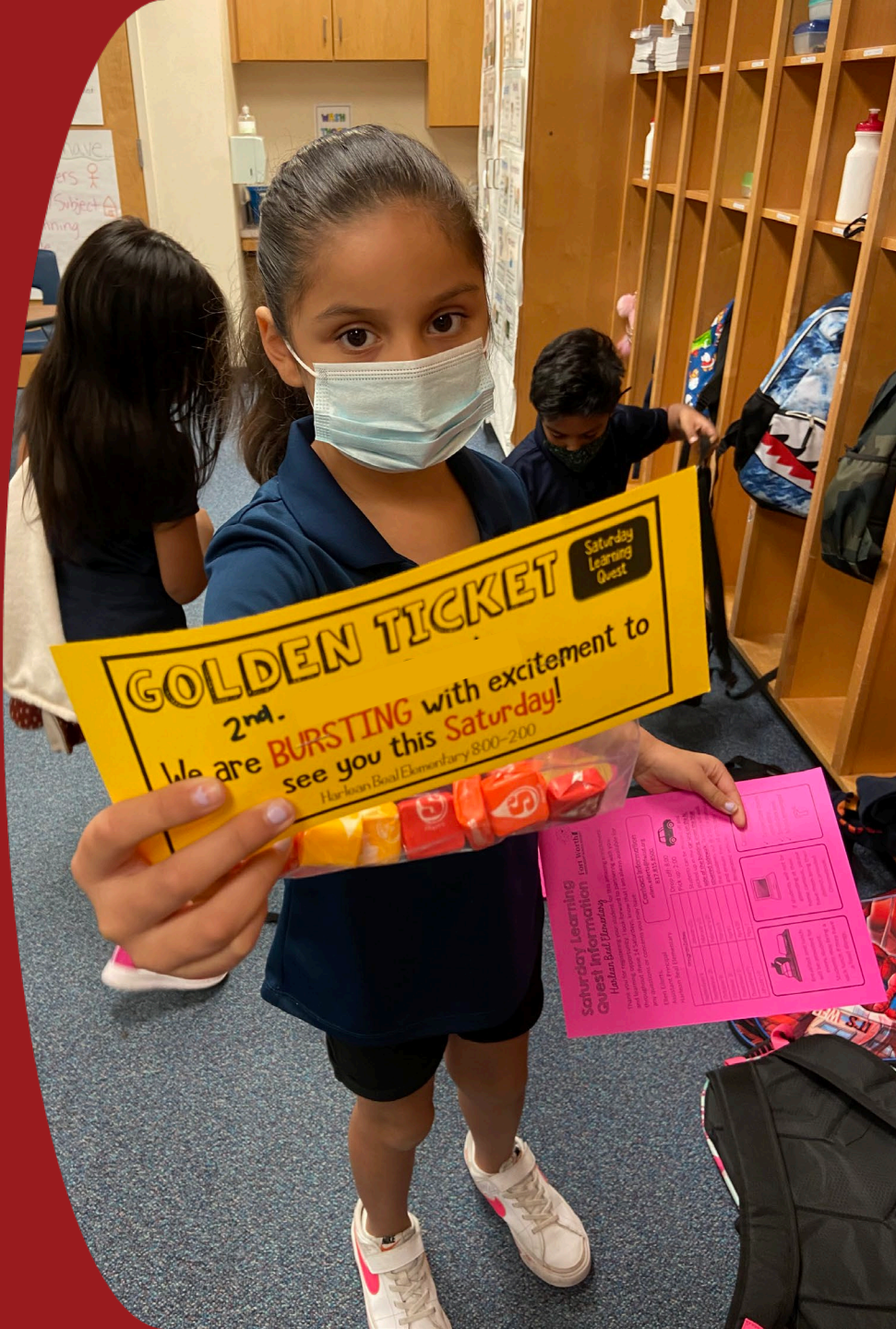
What is Saturday Learning Quest?

Targeted learning opportunities for academic growth and social emotional support over 14 Saturdays.

- ✓ A total of 24 elementary schools will host the program, representing each school pyramid, from 8 a.m. to 2 p.m.
- ✓ First, second, and third-graders are eligible to participate.
- ✓ Free transportation is available and students will receive both breakfast and lunch.
- ✓ Saturday Learning Quest will also offer Adult Education classes and Parent University.
- ✓ There will be incentive prizes for student attendance and for parent engagement.
