Radon Sampling Assessment

Dear Mr. Nannestad:

Quality Environmental Services & Technologies Inc. (QUEST) is pleased to assist Douglas County School District with the ongoing radon survey of its schools. At your request, QUEST conducted radon testing at Northeast Elementary School, located at 6598 N. Highway 83, in Parker, Colorado.

Sixty-four (64) AirChek radon test kits were placed on October 3, 2023, and sixty-three (63) were retrieved on October 5, 2023. One (1) AirChek radon test kit was missing from Room 254A at the time of our retrieval. The attached laboratory results specify radon concentrations to be all within the EPA guideline of 4 pCi/L for acceptable radon concentrations.
