Dear Mr. Nannestad:

Quality Environmental Services & Technologies Inc. (QUEST) is pleased to assist Douglas County School District with the ongoing radon survey of its schools. At your request, QUEST conducted radon testing at Building 104 of Stone Canyon Outdoor EdVentures, located at 12163 South Perry Park Road in Larkspur, Colorado.

Three (3) Air Chek radon test kits were placed on January 28, 2020 and were retrieved on January 30, 2020. The attached laboratory report identifies that radon concentrations in all tested locations were above the EPA guideline of 4 pCi/L for acceptable radon concentrations.

Following QUEST's January 2020 radon sampling, a new exhaust fan reportedly had been installed. At your request, QUEST conducted follow-up radon testing at Stone Canyon Outdoor EdVentures, Building 104 in October of 2020.

On October 27, 2020, QUEST placed three (3) AirChek radon test kits in the following locations: the Living Room/Kitchen, Northwest Bedroom, and Southwest Bedroom. The test kits were retrieved on October 29, 2020. The attached laboratory report identifies that radon concentrations in all three tested locations now meet the EPA guideline of 4 pCi/L for acceptable radon concentrations. As such, no additional mitigation or sampling is needed.
