Re: Acres Green Elementary School – 13524 Acres Green Drive in Littleton, CO 80124 Radon Sampling Assessment

Dear Mr. Nannestad:

Quality Environmental Services & Technologies Inc. (QUEST) is pleased to assist Douglas County School District (DCSD) with the ongoing radon survey of its schools. At your request, QUEST conducted radon testing at the Acres Green Elementary School, located at 13524 Acres Green Drive in Littleton, Colorado.

Sixty-one (61) AirChek radon test kits were placed on January 21, 2020 and were retrieved on January 23, 2020. The attached laboratory report identifies that radon concentrations in all locations except Rooms 13A, 16 and the kitchen office (and the duplicate) met the EPA guideline of 4 pCi/L for acceptable radon concentrations.

Since QUEST's January 2020 radon sampling in the school, the ventilation system reportedly has been modified to increase the airflow. At your request, QUEST conducted follow-up radon testing at Acres Green Elementary School in October of 2020.

On October 27, 2020, QUEST placed three (3) AirChek radon test kits in the following locations: Room 13A, kitchen office, and Room 16. The test kits were retrieved on October 29, 2020. The attached laboratory report specifies the detected radon concentration in the kitchen office is below the EPA guideline of 4 pCi/L for acceptable radon concentrations. Although the radon concentrations in Rooms 13A and 16 exceeded the EPA guideline, DCSD has chosen to re-purpose both rooms into unoccupied storage space, thus no additional mitigation or sampling is needed. DCSD has agreed to post signage on both doors stating that they cannot be utilized as classrooms or meeting spaces. If DCSD opts to utilize these two rooms in the future, additional mitigation and re-sampling will need to be conducted prior to occupation.
