Re: DCSD Pine Grove Elementary School 10450 Stonegate Parkway in Parker, Colorado September 2022 Follow-Up Radon Sampling Assessment

Dear Mr. Nannestad:

Quality Environmental Services & Technologies Inc. (QUEST) is pleased to assist Douglas County School District with the ongoing radon survey of its schools. At your request, QUEST conducted follow-up radon testing at Pine Grove Elementary School, located at 10450 Stonegate Parkway in Parker, Colorado.

Seventy (70) AirChek radon test kits were placed on May 2, 2022, and they were retrieved on May 4, 2022. Sample analysis identified the radon concentration to be above the EPA guideline of 4 pCi/L for acceptable radon concentrations in rooms 100 (storage), 200 (storage), 202, 203, 207, and 300 (storage). The detected radon concentrations in all other tested locations were below the EPA guideline. QUEST recommended that further radon mitigation efforts be undertaken, including inspection of the ventilation system. At your request, QUEST conducted additional follow-up radon testing in September of 2022.

On September 6, 2022, QUEST placed eight (8) AirChek radon test kits (including 1 duplicate and 1 blank) in the following locations: rooms 100 (storage), 200 (storage), 202, 203, 207, and 300 (storage). The test kits were retrieved on September 8, 2022. The attached laboratory report identifies that radon concentrations in all tested locations now meet the EPA guideline of 4 pCi/L for acceptable radon concentrations. As such, no additional mitigation or sampling is needed.
