Dear BCSD Community,

I am pleased to report that on April 24, our Board of Education approved the proposed 2024-25 School Budget. Please mark your calendar to participate in the budget vote to be held on May 21.

Following deliberation sessions and fueled by the anticipated restoration of nearly \$1.6 million in Foundation Aid, the Board's Proposed Budget adopted the Superintendent's Budget of \$155,825,000. The Board also directed maintaining five Elementary Coordinators, which had initially been proposed for reduction, at a net cost of about \$380,000, a figure that the administration can work with in managing the \$155,825,000 budget number over the course of the next year.

I want to thank every single person who joined legislators in imploring the governor to restore our Foundation Aid on behalf of BCSD students. Your advocacy was successful! For more complete budget details, I invite you to explore our website: www.bcsdny.org/Page/3007

^{*} In the event of a contingent budget, the District is required to maintain the 2023-24 tax levy. The expense budget would require a decrease of \$4,053,380. This would necessitate elimination of proposed certified and classified staff positions, professional development, curriculum enhancements, co-curricular and athletic program enhancements. Additional deductions would be required in general education teaching positions, supplies and contingent expenses, such as instructional and operating equipment.

The budget to budget increase would be 0.50%. This statement of assumptions is projecting a contingency budget for the 2024-2025 school year, should the proposed budget be defeated pursuant to section 2023 of the Education Law.

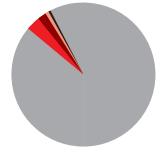

What happens if the budget doesn't pass?

Should the proposed budget be defeated, \$4,053,380 in non-contingent expenditures would need to be removed in a contingent budget. These may include equipment purchases and repairs, unreimbursed community use of facilities, extracurricular clubs, athletics, electives and advanced placement courses, certain student supplies and staffing reductions, which may lead to increased class sizes.

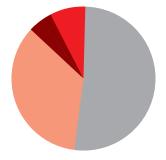


Where will the money come from?

Student Success

Literacy

Bedford Central School District is deep into the work of aligning our literacy instruction to the Science of Reading and selecting a new literacy curriculum. This process has included examining, rethinking and improving some critical areas.

- Professional Development: BCSD is full-steam ahead to support
 the full implementation of literacy curriculum, instruction and
 professional development aligned to research on the reading
 brain. Professional development includes training in Language
 Essentials for Teachers of Reading and Spelling (LETRS) and work
 with outside consultants like Dr. Molly Ness, the Windward
 Institute and Haskins Global Literacy Hub to ensure our teachers
 are empowered to hit the ground running with our new curriculum.
- Making Shifts in Instructional Practice: Our teachers are also being empowered to make instructional shifts aligned to reading research. Dr. Ness has begun working with staff this year to support those instructional shifts in the classroom. The proposed budget includes hiring a literacy coach to support ongoing professional learning in the area of literacy.
- Curriculum Resources: The Literacy Committee has been involved in a two-year process to select new resources aligned with the Science of Reading. The group will make a recommendation for the new curriculum in the spring to be adopted in the fall of 2024 for grades K-5.

"BCSD's approach has been intentional, well-researched, and thoughtful — even though it's been a relatively speedy process," said Dr. Ness, a nationally recognized literacy researcher, writer, educator and speaker. "The school and district leadership understand the need for change, understand brain-based reading instruction, and respect the commitment and knowledge of their teachers. It's also exciting to see a district honoring the linguistic richness of the population at Mount Kisco, a school that truly understands the complexities of biliteracy."







Bridges in Mathematics

BCSD is in year two of implementing the new elementary math program, Bridges in Mathematics, in grades K-5, as well as the Bridges intervention program. We are thrilled to be seeing a high level of student engagement. Teachers report that students are demonstrating a stronger understanding of math concepts, flexibility with numbers, and recognizing complex patterns in numbers. The way we hear students talk about math, numbers, and concepts (referred to as "math talk") has also improved tremendously.

Elementary Math Coach, Michelle Grier, continues to support teachers immensely. The district has also brought in Bridges trainers who have done professional development to support classroom teachers, tiered support and learning specialists. We are now beginning to explore math curriculum and instruction at the middle school level as our middle school teachers are readying themselves for the students who have received math instruction with the new Bridges curriculum.

Safety & Security

There have been a few major changes in safety and security this year. One of the biggest is that Fox Lane became a closed campus. Visitors can no longer drive onto campus during the school day without a reason. A safety monitor in an electric vehicle vets all visitors at the entrance before allowing anyone on campus.

Other important changes include adding automated external defibrillators (AEDs) to all athletic fields, incremental upgrades with security cameras (which will continue to be added to our elementary schools), consulting with BOCES on our safety plans and proposing an extra Community Resource Officer for next year.

Student Well-Being

The district has continued to advance inclusive systems of student support that strengthen culture and climate and create personalized pathways to success. Just a couple of examples include:

The Accessibility Team

The Accessibility Team is a multidisciplinary team composed of BCSD staff members with diverse expertise and experience, who strive to foster an inclusive and welcoming environment for all individuals. The group works to proactively remove barriers and create equitable access to school events, ensuring that every member of our community can participate in a meaningful way. Sometimes this means considering physical barriers for students at certain events. Other times, it's providing headphones, fidget toys and a quiet place to regulate. Another key component is making sure school events are communicated clearly and effectively to all parties who are involved.

"We aspire to be a model of inclusivity, where diversity is embraced, and everyone has an opportunity to engage in events and experiences."

Multi-Tiered System of Supports

The district has begun to make intentional shifts toward ensuring all students have the tools necessary to become successful adults. Our vision for the BCSD Multi-Tiered System of Supports (MTSS) is a systemic commitment to high-quality education and

evidence-based instruction that supports students' academic, social-emotional and behavioral needs, leading to higher student engagement, a sense of belonging and stronger achievement.

MTSS work started in Curriculum Council with a self-study of the systems already in place and identifying gaps and opportunities for improvement.

RULER lessons and strategies continue to be regular parts of our classroom communities, where students learn how to Recognize, Understand, Label, Express, and Regulate their emotions.

Inclusivity

Communication boards were installed at West Patent and Bedford Village elementary schools. The communications boards are a tool posted on playgrounds that aims to prioritize communication for every student. One side of the board includes letters and icons that help promote social language and interactions. The other side has a RULER meter, something students are very familiar with, as a way to identify, communicate and express their feelings.

In addition, our district continues to move forward with inclusive education with district wide celebrations of events such as National Inclusion Week and Neurodiversity Week, during which students learned about the different ways people think and how we can honor and celebrate our unique brains.

Voter Registration

To vote in school elections, you must be a registered voter for either school elections or general elections. To be eligible to register, you must be a U.S. citizen, 18 years of age by the election date and a resident of the district for at least 30 days before the election. The last day for registration with the district is May 16, 2024.

Absentee/Early Mail Ballots

An application must be submitted before an absentee/early mail ballot can be provided to a voter. Applications for absentee/early mail ballots must be completed and received by the District Clerk at least seven days before the election if the ballot is to be mailed to the voter, or the day before the election if the ballot is to be picked up by the voter.

Absentee/early mail ballot applications are available from Sandra Speyer, District Clerk, at the Administration Building on the Fox Lane Campus during regular business hours (8:30 am – 3:30 pm) or by downloading the application: bcsdny.org/Page/3016.
