

Greetings and welcome to Centaur Nation! As we gear up for the start of a new school year, we are excited to welcome our newest members of the community to our school and athletic program. We certainly hope you will consider participating in athletics as part of your Woodstock Academy experience.

I wanted to pass along some important information to ensure your student is ready to go on day one. There are three tasks that need to be completed before any student can participate in athletics.

- 1. Register on <a href="www.familyid.com">www.familyid.com</a>. Click on "find a program" and type in Woodstock Academy. It will direct you to our 2017-2018 registration page. This must be done by a parent or guardian.
- 2. All student-athletes must turn in a copy of their most recent physical to the nurse's office prior to the first day of practice. Physicals are good for 13 months from the date of the exam. Students with expired physicals will not be permitted to participate in practices or games until a new physical is turned in. It is the responsibility of the student-athlete and the parents to make sure a current physical is on file with the nurse's office. ## Welcome to The Woodstock Academy,

We are so excited to have you join Centaur Nation! Below is a list of instructions to help get your student account ready for the first day of school. Please remember that if you have ANY problems or questions setting up your account, you can call the Information Technology Office at (860) 928-6575, option 8, and they will happily help you set up your accounts. Their summer hours are Monday – Thursday 7:00 a.m. - 3:00 p.m.

Here at The Academy, all students use a myWA Network Account. This account is a set username and password that will be used for your WA student email account, the WA Mobile app, The Academy website, VMWare (virtual computers on campus), WiFi authentication, PowerSchool, and many other systems! It is very important that you remember these credentials.

To set your myWA Network Account password from home, you will need to open an Internet browser and navigate to woodstockacademy.org/passwordreset then log in with your myWA Network Username and temporary password from above. If you do not have a computer at home with an Internet connection, you can come to the Bracken Memorial Library over the summer and use one of their computers to set your password.

After you set your password, you can take a look around the virtual desktop, but more information on how to use virtual will come from teachers as you use it.

Now for your email! To get to your student email, which is where important info from The Academy is sent, you will need to go through the school's website, woodstockacademy.org then click the icon on the right toolbar that says "myWA" then "sign in." After you are signed in, you will notice a gold bar at the top of the page. Click "Students" and then click "Email Portal" and log in using your email address, ahebert2021@student.woodstockacademy.org, and your network password\*.

NOTE FOR PARENTS: separate login credentials for myWA on the WA Website and the WA Mobile App will be provided to you closer to the beginning of the school year. Parents should not sign into the WA Mobile App or Website with their childs credentials.

While there have been significant changes, the foundation of this historic institution will not change. As an educational institution, our focus is always on the individual student. As activating and setting up your myWA network account and WA Email is the most important task, we have enclosed a letter from our Information Technology Office with detailed instructions to assist you. It is important that your account is set up right away, as all future information from The Academy, including how to check your schedule, will be sent to that email address.

The Academy is a one-to-one environment; each student receives an iPad. Information concerning the schedule and the process for the distribution of iPads and activation of new student myWA (network) accounts is included in the letter from the Information Technology Office.

To specifically help families with this transition, we suggest you download our The Woodstock Academy App (Apple or Android devices), or follow us on one of many social media platforms that allow families to have important Academy information at their fingertips.

Our annual Family Traditions Day will be held on Sunday, August 27, at North Campus, from 12:00 to 3:00 p.m. This orientation activity will help students and families transition into our Academy community. You will have the chance to meet members of our staff, fellow students, and walk the campus.

The required first day of school for all new students is Monday, August 28. This **New Student Day** is scheduled before our returning students arrive on campus. This allows new students to meet their teachers, familiarize themselves with the campuses, and find out where buses arrive and depart each day, among other important information. This half-day program ends at 11:30 a.m., and transportation is provided by the student's town.

The first event of which you should be aware is the Freshman First Night on October 13. This event is solely for freshman students, and provides a unique opportunity for freshmen to meet each other in a non-academic setting. More information on this event will be forthcoming, as the date gets closer.

Our 2017/2018 The Woodstock Academy Student Handbook will be available on our website, and will also be downloaded onto each of the iPads issued to students this year. Please review the handbook, as it should answer all questions related to academic and behavior expectations.

#### Dear Colleagues:

As we enter the final stretch of our summer break, we wanted to send an update on our preparations for your return and the return of our students in a few short weeks. People have been very busy moving into the new South Campus, and preparing the North Campus for everyone's return. We hope you have had the chance to get together with family, relax by a body of water somewhere, hike the highest mountain, or visit a foreign country. While every summer is busy, this year, our 216th, has been extremely hectic as we transition from a day school to a day and boarding school.

The addition of South Campus has already enhanced many of our programs, and will continue to enrich the educational experiences of our students, both in and out of the classroom, twenty-four hours a day. South Campus affords us the opportunity to increase the space for both our fine arts and robotics programs, increase our athletic opportunities with the addition of a second gymnasium and fitness center, and provide a traditional boarding environment for our diverse boarding population. There are many changes, and we look forward to sharing the details with you on your return! This is a historic time for The Academy, and Holly and I are honored to be helping to lead this institution.

Although we all realize there will be growing pains and change as we move forward, your ability to build powerful relationships with students, and help to mold their future, remains our bedrock. Regardless of the room you teach in, the campus you teach on, or the subject you teach, you are helping to change the world each and every day. Brad Henry, Governor of Oklahoma, said it best when he stated, a "teacher can inspire hope, ignite the imagination, and instill a love of learning."

It is important that we acknowledge the many people who have gone above and beyond over the summer to make this transition possible. The Technology Department has made the printing, phones, security, Wi-Fi, etc., work seamlessly on both campuses. The Maintenance Department has moved and built many items so that everything will be in its new locations for your return. The Custodians and Housekeepers have cleaned and waxed everything to provide the school with that "first of the year" look.

We have also switched our student information system to PowerSchool. This long-awaited change will provide our students and parents with up-to-the-minute information on student progress. This new system will increase communication with families, our most important stake-holders in our students' educational process.

Through the addition of South Campus and the boarding program, we will have about 20 new members joining our community. Although some of our new family was introduced at our final staff meeting in June, we will introduce all of our new members on our first PD day. This is an outstanding, diverse group who will enhance the overall program and strengthen The Academy and its ability to meet its mission as an educational institution.

By any measure, whether reviewing the assessment or survey data, the 2016-2017 School Year was a great success. Our students grew educationally in a very caring and supportive environment. A few highlights are that 97% of our students reported that their classmates are friendly, over 93% stated that teachers are willing to provide extra help when needed, and 94% reported that they felt there was a trusted adult they could go to for help. These data points are in addition to the 100% graduation rate, and the great successes we had in student achievement on the College Board Assessments. It is important that we all recognize the role that each and every one played in all of these great successes.

While we don't want you to leave your easy chair too soon, there are a few dates of which we want to make you aware:

- All new teachers should report to school for orientation in the Bowen main office conference room on Tuesday, August 15, from 8:00 a.m. to noon.
- The schedule for all the opening of school activities is included with this letter.
- All faculty and staff members are expected to attend the Professional Development day on Wednesday,
   August 23. A light breakfast will be served at 7:30 a.m., followed by the opening staff meeting at 8:00
   a.m. in the Bates Auditorium. This will be a full day for faculty and non-certified staff members. A light
   lunch will be provided.
- The Professional Development day on Thursday, August 24, is for faculty only. Please know that we have worked hard to provide time to set-up your classroom. This time has been carved out of the required activities we have to conduct. Non-certified staff are not required to attend any activities this day; however, you are certainly welcome to attend, but the time would be uncompensated.

The Board of Trustees Reception for all staff is on Thursday, August 31. This special event includes service awards recognition, as well as a welcome to all our new members. The invitation was previously emailed to all community members. If you have not done so already, kindly RSVP to Sue Straub by August 21.

All new students report to school on New Student Day, Monday, August 28. All staff is expected to report to school on this day. As this is a school day, it is important that all staff follow their schedule on that day.

All students will return to school on Tuesday, August 29. Please note that this is also an Advisory Day.





#### THE WOODSTOCK ACADEMY LEADERSHIP THEORY
