The LEA has engaged students, families, school and district administrators, including but not limited to, the special education director, teachers, principals, school leaders, other educators, school staff, and all other stakeholders representing the interests of children with disabilities, English learners, children experiencing homelessness, children and youth in foster care, migratory students, children who are incarcerated, and other underserved students in meaningful consultation via survey and administrative meetings. JCSD solicited public comment during the planning phase beginning May 5, 2021 with a completion date of May 12, 2021. The survey link was posted on and disseminated through the JCSD Facebook page, the JCSD website, school web-based mediums, and in parent and community member newsletters. Additionally, administrative meetings were held to discuss funding parameters and the immediate COVID-19-related needs of the Jackson County school district as a whole. These meetings were comprised of a diverse group of stakeholders, which included principals, various staff member from various departments, community members, healthcare workers, and other essential personnel. Representation at each meeting varied depending on the immediate COVID-19 related topic of discussion.

\* 2. Provide an overview of how the LEA solicited public input and how it was considered for the development of the LEA's plan for the use of ARP ESSER funds.

As stated in the response above, a 7-question survey was constructed to obtain public comments for the creation of the ESSER III ARP roadmap and was distributed to all stakeholders of the Jackson County School District. The survey consisted of targeted questions focused on determining the needs in the following areas: addressing learning loss, school facility improvements and/or repairs need for the reduction of COVID-19 virus transmission through the improvement of air quality and environmental health hazards, parent and family engagement activities designed to provide assistance to families to support students including, but not limited to, distance learning opportunities, educational technology, adaptive equipment to aid in regular, substantive educational interaction between students and classroom instructors, and support for children from low income families, with disabilities, racial and ethnic minorities, English learners, homeless, and foster care youth, and student social and emotional needs. All stakeholders were provided seven days to complete the survey, which afforded them the opportunity to type in a variety of authentic responses. Upon completion of the survey, all 598 participant responses were sorted into categories and distributed to the district office administrative team for review and planning purposes. JCSD directors and assistant superintendents reviewed the survey results and discussed ESSER III allowable expenditures. Each director and attendance center assistant superintendent were responsible for extracting allowable initiatives from the survey results and administrative team input, and proceeding with the development of a budget narrative outlining specific expenses using ESSER III funding.

Needs Assessment

\* 1. Describe how the LEA will identify the impact of the COVID-19 pandemic on student learning and student well-being, including identifying the groups of students most impacted by the pandemic.

Jackson County School District will assess each student at the beginning of the 2021-2022 school year using various academic and social-emotional diagnostic tools and reassess them throughout the school year. Once students are assessed and needs revealed, local schools will form intervention groups and assign academic and social-emotional interventionists appropriately. Additionally, after school tutors will also be utilized to provide compensatory and remedial services for at-risk students.

Jackson County School District schools will provide all students prescriptive instruction based on results of individual students' i-Ready diagnostic assessments. In addition, all purchased programs will be utilized to maintain a wide variety of learning opportunities which will be customized based on academic needs of students, as well as to equip teachers with the resources and skills needed to deliver highly effective instruction. These resources will be available for prioritized content and intensive tutoring both during and after the scheduled school day.

Jackson County School District will continue the existing program of academic services for students. The purchase of programs and services will ensure continuity of high-quality instructional resources. Teachers will engage in Summer training to develop curriculum for an online Learning Management System.

Teachers will also participate in professional development opportunities that increase overall teacher efficacy in daily lessons and instructional interventions and the online learning management system. The professional development activities will increase their ability to effectively use technology to deliver creative, meaningful instruction in an online learning environment as well as delivery of highly effective daily classroom instruction to address those students most impacted by the pandemic.

\* 2. Where possible, identify the data sources the LEA will use in diagnosing areas of need, including data on the academic, social, emotional, and mental health impacts of lost instructional time.

Curriculum Associates, EnCase Benchmark Assessments, School Status, Imagine Learning, USA Test Prep, Chalk Talk, Reflex Math, Lexia, Edgenuity, are all online programs that will be used to diagnose academic areas of need. OTIS, Nearpod, and feedback from positive behavior personnel will provide data for social and emotional needs of students due to lost instructional time. Character Strong and Conscious Discipline are programs that will be utilized district-wide to address the social and emotional learning and will be available for all students and staff affected by the global pandemic. The district will address social, emotional, mental health, and other needs of students and staff with an increase in nursing staff, behavioral specialists, mental health professionals, and social/emotional learning curriculum for all of JCSD schools.

\* 3. Describe how the LEA plans to safely return to in-person instruction and sustain the safe operation of schools.

The Jackson County School District will return to traditional school operations with a primary goal of in-person instruction. Jackson County School District will continue the existing program of academic services for students. The purchase of programs and services will ensure continuity of high-quality instructional resources. Both teachers and students will be participants in face-to-face learning, which will include safe and healthy instructional practices focused on addressing the students' academic needs and the students' social/emotional needs. It will be expected for students and staff to arrive at and dismiss from their assigned school as normal as possible following all mandates stipulated by state and local officials. Moreover, staff and students will follow a traditional bell schedule ensuring that all students receive all of the state's required instructional minutes in-person. Students who participate in our career and technical education program will continue to participate in both activities during the school year and Summer activities, which includes STEAM/STEM Summer CTE camps. JCSD will provide transportation and bus schedules will operate as normal as possible with a continued emphasis on cleanliness and safety, to include assigned seating. JCSD will not require students or adults to wear masks, unless otherwise directed to do so by state and local officials, during transporting. Each attendance center will issue bus-riding precautions and procedures to address seating arrangements, cleaning schedules, and loading/unloading order. The transporting of students participating in our career and technical education program will include the use of an additional one to two buses from each attendance center. Based on the number of students being transported, there will be smaller numbers being transported to allow for social distancing on the bus. All buses utilized for the transporting of these students will be cleaned in between shifts and at the end of every school day. Meals will be provided to students in cafeteria dining rooms, classrooms, hallways, via to-go carts for grab-and-go breakfasts, and via outdoor seating area to ensure proper distancing. During the Summer and the school year, parents have had the option to pick up meals for both Summer learners and distance learners. At the CTE facility known as the FABLAB, students were given the option to eat outside or within the FABLAB. Although virtual learning will not be offered as the traditional mode of instructional guidance, the Jackson County School District is prepared for any mandated school closure, as students and staff are equipped with the



technological resources to provided both blended learning opportunities and synchronous learning opportunities. Lastly, the Jackson County School District will provide students and staff with a safe and healthy learning environment by providing the following:

- Partnership with local health agencies, to include Coastal Family Health Center, who is available on-site with no out-of-pocket cost
- Thermometers in each classroom used as necessary
- Hand washing/sanitizing stations throughout school buildings as needed
- Continued sanitizing protocols in classrooms, bathrooms, buses, and other areas to prevent the spread of any illness, including COVID-19
- Ongoing monitoring of COVID-19 cases

\* 4. What prioritized needs did the LEA identify during the pandemic?

The Jackson County School District identified several needs during the global pandemic. However the following were prioritized to ensure the continuation of educational and operational services: delivery of instruction and specialized educational services, sanitization and maintenance of facilities and transportation, improvement of air quality, and other specialized educational services for all subgroups.

\* Describe how the proposed activities/use of funds support the focus area and how the effectiveness of the activities will be assessed.

All local school principals have developed academic intervention plans with an outlined monitoring explanation to ensure that rigor and relevance is maintained during all intervention/remediation services. Teachers will also continue to promote the overall academic development of all students using their online platforms to communicate with parents and students to address instructional deficits and meet the academic needs of students. Students and teachers will use data to drive goal setting to promote high standards throughout the Jackson County School District. Funds will be used to employ additional academic and social-emotional support staff, including instructional coaches, summer tutors, and positive behavioral specialists.

The development of curriculum for the online learning management system will be provided during the Summer 2021 and will aid teachers and students both in-person and remotely through the addition of a variety of learning resources formatted for both learning environments. JCSD will assess each student at the beginning of the 2021-2022 school year using various diagnostic tools, and reassess them during the 2022-2023 school year if carryover ESSERII funds are available for usage. Once students are assessed and academic gaps revealed, local schools will form intervention groups and assign interventionists, teachers, and/or tutors appropriately. Additionally, summer school teachers/tutors will also be utilized to provide compensatory and remedial services. It has also been decided that students in at-risk populations will be targeted for summer learning opportunities and will benefit from summer curriculum development. Teachers of at-risk populations will be encouraged to participate in summer curriculum development.

\* 2. Describe how the LEA will use ARP ESSER funds to implement prevention and mitigation strategies that are, to the greatest extent practicable, in line with the most recent CDC guidance, in order to continuously and safely operate schools for in-person learning.

Our return to school policy for the Jackson County School District is in accordance with the MDE guidelines. All students will return to a traditional setting. Setting a positive tone will be immediate with opening school celebrations as appropriate and in line with MDE guidelines. Pre-pandemic policies, procedures, schedules, and activities will return adding to the positive atmosphere of the campus. Procedures will be utilized that will encourage student compliance as well as maintain class attendance. Character Counts will be implemented school-wide with the objective of aiding students in becoming more equipped to deal with social, emotional and mental issues. More parental involvement will be encouraged with opportunities to participate in student academics and activities.

JCSD will provide a safe and healthy learning environment by utilizing the following methods: Partnership with local health agencies • Coastal Family Health Center is available on-site with no out-of-pocket cost • Thermometers in each classroom used as necessary • Hand washing/sanitizing stations throughout school buildings as needed • Continued sanitizing protocols in classrooms, bathrooms, buses, and other areas to prevent the spread of any illness, including COVID-19 • Ongoing monitoring

If a student or staff member tests positive for COVID-19 after school starts the school district will follow all federal, state, and local mandates related to students and staff members who test positive for COVID-19. • In-person learning will continue for other students in his/her class. • A student or staff member who tests positive will follow directives given by his/her medical care provider.

If students or staff members who show symptoms of COVID-19, those students and staff members who show symptom will be referred to the school nurse for evaluation of symptoms. School officials will communicate to parents if their child is directly exposed to COVID-19. COVID-19. Cases will be regularly reported via the district website.

The LEA will spend the remaining ARP ESSER funds for school facility repairs and improvements to enable operation of schools to reduce the risk of virus transmission and exposure to environmental health hazard, and to support student health needs. Inspection, testing, maintenance, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and non-mechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning fans, control systems, and windows.

All students, teachers, and other program beneficiaries will have equal access to construction benefits, instruction, technology, nursing services, professional development opportunities to improve intervention and virtual learning curriculum, all remediation/intervention services and any other service/activity utilizing ARP ESSER III funding. All schools in the Jackson County School District will utilize FY21 ARP ESSER III funds for various services, personnel, and/or projects. Additionally, all teachers are being offered the opportunity to obtain a recommendation for summer curriculum development based on their ability to provide high quality resources and/or their interest in/skill level with specific types of resource platforms. Students will be selected for summer learning based on academic necessity and/or at-risk category. Students, who have been identified for special education services, will also have both their reading and math levels assessed to ensure that their specific deficits are addressed. Overall, students and teachers, will have an equal opportunity to receive the benefits from every project or activity carried out under ARP ESSER III. Instructional and technology coaches will be on hand to observe and encourage high standards during curriculum development. Moreover, student progress will be a goal from the beginning, with the following as specific goals: obtaining above average state and local assessment scores and above average state goals for both general education, special education, and career technical students, inclusive of all homeless, foster care, and English learners. The JCTC CTE program further extends the promotion of high expectations by providing specialized staff

development, career coaching, craft committees and weekly staff meetings.

JCSD will use ESSERIII funds to provide schools with additional positive behavior specialists who will work with teachers and students to promote a positive and supportive learning environment for all students. Specialists will foster positive behavior interventions to minimize the occurrence of exclusionary discipline measures. Additionally, the CPI Nonviolent Crisis intervention Training program will be implemented to assist students in obtaining skills for a positive and supportive learning environment.

\* Summarize the LEA's plan for reporting, monitoring, and auditing supports and capacity related to ARP ESSER funds.

Each school has developed a plan for closing COVID-19 learning gaps. Each student will complete an assessment at the beginning of the school year to determine skill weaknesses. Schools will address identified academic needs through the use of certified tutors, schedule adjustments, and careful monitoring of academic progress throughout the school year. The i-Ready diagnostic assessment will be given three times during the school year to both in-person and virtual students grades Kindergarten through 8th. Data from these assessments will be analyzed to monitor students' academic progress as well as to provide targeted, customized learning opportunities for all students. Students in high school will be monitored through a diagnostic or benchmark assessment that is appropriate for the courses in which they are enrolled. Some examples are Edgenuity, USA Test Prep, and TE21 (Certica) benchmark assessments.

Monitoring for the effectiveness of the additional staff and services will include collecting monthly data on student attendance, grades, and discipline. Reports will be monitored and maintained at the school and district level for appropriate and effective use of ARP ESSER Funds.

Administrators at each Jackson County School District school will follow JCSD and Mississippi School Board policies related to staff observation and feedback for all instructors, both in-person and virtual.

Jackson County School District conducts an annual curriculum department survey which gathers feedback from all staff regarding the effectiveness and usage of instructional programming and supports. This will be a continued practice.

Both the Superintendent and the supporting administration staff will oversee that funds for ARP ESSER are utilized as submitted in the plan and verify checks and balances for the maximum benefit of educating all students.
