District Improvement Plan: School Year 2019-2020

District Name: Pharr - San Juan - Alamo ISD

The Mission of PSJA Thomas Jefferson T-STEM Early College High School is to help all students discover a purpose and develop college, career and global citizen capacities to the fullest while earning college core completion or a postsecondary degree by high school graduation.

Demographics Summary: We currently serve 770 students in grades 9 – 12 from the tri-city area and beyond. We are comprised of 98% Hispanic, 93% economically disadvantaged, 3% Special Education, 3% 504, 2% Migrant, 12% English Language Learners, 16% Gifted & Talented and 46% at risk students that have committed to an early college education.

Comprehensive Needs Assessment Summary: Having earned an A by the Texas Education Agency and ranking 36th in the state through the Best High Schools US News & World Report, we are steadfast on continuing our tradition of excellence. An overall score of 93 shows we have room for improvement. Our struggle lies in the areas of literacy and academic growth. Our 2019 data shows 36% of our 9th & 10th grade students are not on grade level in English; 53% of that are English Language Learners and 10% Special Ed students. Furthermore, our TELPAS results are at 30% which is 6 points under the federal target. Conversely, 70% of our 9 – 12 grade EL's are not advancing in English.

Curriculum/ Instruction and Assessment: Through our weekly on-campus professional development, teachers learn strategies to create an optimal learning environment in their classroom. Teachers continue to use the common instructional framework, 4 C's, SIOP and fundamental 5 to deliver quality lessons. To address our literacy needs, we will dig into the the intellectual prep of academic vocabulary and inferencing through classroom discussion and writing. Strategies like content driven exchanges and looping will ensure that EL students have the oral practice they need to advance in the TELPAS assessment. We will use technology, Newsela and new teacher center resources to maximize our focus skills.

Summary of Goals: By May 2019, we will increase student English language achievement by 6% to increase our on grade level percentage from 64% to 70%. We will close the achievement gaps in our sub-groups by 5% as well as increase our overall academic growth in Domain II part A from 69% to 75%.
