EC Literacy Targeted Professional Development Plan

Teachers will conduct small guided reading groups daily with a dedicated language arts block of 120 minutes. Phonics, spelling and word study, vocabulary, writing, fluency, and comprehension will be a part of the language arts block daily. Materials such as letter tiles and leveled guided reading books will be purchased with general funds. Leveled books related to the curriculum in science, social studies, and math will be purchased with IMA funds to promote reading and vocabulary development across the content areas. Digital resources will be purchased with IMA funds, bond funds, and local funds to support varying learning materials, at-home learning if necessary, data analysis of student growth, and increased student ownership of learning. Teachers will be responsible for implementation of the curriculum with students, and administrators will be responsible for monitoring and supporting the teachers to ensure the best learning experiences for students. The district will be responsible for supporting campuses in securing the resources necessary for strong teaching and learning to occur. The expectation in 2020 will be for small guided reading groups to happen daily and continue from year to year in grades PK-3. These resources will be added to yearly as funds allow.

PROFESSIONAL DEVELOPMENT RECOMMENDED: All PreK through 3rd grade teachers will complete The Science of Reading Academies over the next three years. Guided Reading/Small group instruction will be conducted at all grade levels. The campus instructional coach will support all grade level teachers with implementation of research based instructional strategies. All HS and PK teaching staff will complete the eCIRCLE Professional Development Series with a focus on Letter Knowledge, Written Expression and Small Group Instruction. Professional learning opportunities will be both online and in person and based on progress monitoring data that is collected and analyzed three times per year.
