### Our Learner-focused Strategic Plan: 2024-2027

Thank you to everyone who dedicated their time and provided input to the development of our new three-year strategic plan. As in previous years, we relied on our Leadership Improvement Model to pinpoint our most critical areas of need based on historical data and aligned these with our future goals to shape our final objectives. In a previous HOPE Note, I shared our Golden Circle for team member feedback, and I appreciate everyone who responded and provided suggestions to refine our final version.

Of note, Our objectives are designed around our seven Critical Success Factors (CSFs), with Teaching and Learning at the core of everything we do. We must remain learner-focused, as this is fundamental to our purpose and existence as an institution.

At a recent board meeting, I presented our progress on the previous plan and unveiled our new strategic objectives, detailed on page 2. Throughout the summer, the leadership team will continue to fine-tune these objectives, measures and targets, focusing on our internal processes for capturing, monitoring, and reporting our progress over the next three years. The final plan will be distributed to all team members and stakeholders in August, allowing us to start implementing our annual action plans in September.

We have set ambitious goals for ourselves because we owe it to our learners, our community, and each other to consistently improve our district as an institution of learning, a workplace, and a community in which to raise our children. Our strategic objectives, along with their corresponding measures and targets, are listed below. Any revisions made over the summer will be included in the final plan.
