GENERAL INFORMATION

Driving a vehicle to or from NMTCC is viewed as a privilege. North Penn High School session students may not apply for a Parking Pass. In order to qualify for a driving pass, students must:

1. Pay a non-refundable payment of **\$75.00** (cash OR check) for a permanent driving pass.
2. Maintain at least a "C" average
3. Not have been absent more than (5) days each marking period.
4. Submit a written confirmation from their employer and/or parent confirming the days and starting time for employment.
5. Submitting student must have a current signed Student Handbook Signature sheet on file.

NORTH MONTCO TECHNICAL CAREER CENTER DRIVING PRIVILEGE RULES

1. This pass gives permission only for the driver to drive to/from NMTCC.
2. Student must comply with all the driving requirements as specified in the current student handbook.
3. Student parking is restricted to the specific designated parking lot.
4. While on school property, students are required to obey the 15 M.P.H. speed limit and yield the right-of-way to school buses and pedestrians. (Strictly Enforced)
5. Students may not go to their cars during the school session without a pass from their instructor. Pass must be presented to the main office when exiting and re-entering building.
6. The NMTCC parking sticker must be visible at all times.
7. Students who drive must arrive at or before their sending school bus arrival time.
8. Students who drive will be dismissed at their sending school district's dismissal time.
9. NO loitering outside your vehicle. No tailgating. No littering.
10. NO loud radios, horns or racing/revving engines.
11. NO student is permitted to exit through North Penn's bus garage.
12. All vehicles will operate safely at all times. Students driving a vehicle in a careless/reckless manner will be disciplined according to the student handbook and state statutes.

Any violation of these driving rules will result in the appropriate disciplinary action being taken as specified in the current student handbook, as well as possible revocation of all driving privileges for the remainder of the current school year.

PLEASE NOTE: ANY CAR PARKED WITHOUT A VALID PARKING TAG/STICKER ON NMTCC PROPERTY, MAY BE SUBJECT TO TOWING BY AN APPROVED TOWING SERVICE OR TO IMMOBILIZATION BY NMTCC SECURITY. THE STUDENT WILL PAY ALL TOWING AND STORAGE FEES DIRECTLY TO THE TOWING COMPANY.
