Dear **Transitional Kindergarten and Kindergarten** Parents:

All of us here at the Oakdale Joint Unified School District Mustang Movers Transportation Department consider the safety of our children the most important part of our job. For this reason, we are sending this letter home for you to read. Kindergarten students are to be released at the school bus stop ***only*** to their parents or to a specific person designated by the parents. If the parent has not given us the name of another person who can pick up their child (This includes brothers, sisters, grandparents, neighbors, etc.), we will not release them. Parents MUST arrive at the bus stop location 5 minutes prior to the arrival of the bus. Once the driver acknowledges that you are the approved individual picking up the student, your child will be released from the bus. It is vital that the parent-approved pick-up designee be present and waiting at the bus stop location so if the driver has any questions, you are present and seen for dismissal from the bus. If the parent does not show up at the bus stop to pick up the child, we will return your child to school, and you will have to pick them up from the school site. Any other returns to school because of missed student pickups may be cause for removal from the bus route schedule for the remainder of the school year. For your child's safety, we must be sure who you want your child released to at the school bus stop. If you feel it is safe for your Kindergarten child to walk home independently, we require a Transportation release form to be filled out. You must come into the Transportation Department at the address listed above and fill one out for us to keep on file. ***This action is for the safety of our Kindergarten school bus riders.*** Below is an area where you can fill in the designated names of the people you want your child released to. It is crucial that this form be completed and returned to the school bus driver or brought into our office at the address listed above and given to one of our office staff members. Once again, be sure this form gets back to the Transportation Department or the school bus driver immediately. This form is to be filled out by the parents of the Kindergarten child. Thank you very much for your cooperation, and feel free to call if you have any questions.

TK parents take notice of minimum day schedules! Route times change because all students on the minimum day schedule will ride ***on those days.***
