**1. Make your tax credit donation to any Balsz school on or before April 15th to be eligible for a credit for the previous year.**

*Arizona tax law (ARS 43-1089.01) allows taxpayers a dollar-for-dollar TAX CREDIT if they contribute to extracurricular activities in public schools. Tax credits are only available to individuals; payments cannot be accepted from corporations or businesses. Refunds are not issued.*

**2. Donate any amount up to \$400 for married couples filing jointly or \$200 for a single person filing separately.**

*A donation may be made to one school or split among multiple schools. You can designate your donation for a specific qualifying activity/program, or select "Area of Greatest Need" which allows the school to designate the funds for a qualifying activity/program to best meet the needs of its students.*

**3. Complete this form and enclose your check or money order made payable to the name of the school or donate securely online at [www.balsz.org/taxcredit](http://www.balsz.org/taxcredit).**

*You can mail your form or drop it off at the school or district office (see addresses below.)*

*Mail-in donations must be postmarked by April 15th. You will be mailed a receipt by the district office.*

*If you wish to donate to more than one school, a separate check must be written to each school. Online donations may even be made last minute on the evening of April 15th, and you can print out a receipt online. It's easy, fast, and secure.*

*Please note: The following information is required in order for this donation to be used as a tax credit on your AZ state income tax report. The school district will mail you a receipt for your records upon receipt of the check.*
