Sealed bids for Fire Suppression Sprinkler System for District Warehouse for the Round Lake Area Schools Community Unit School District #116, as described below will be received at the Round Lake Area Schools CUSD #116 Operations Center, 811 Sunset Drive, Round Lake, IL 60073, until 9:00 AM, local time, Monday, July 8, 2024. Sealed envelopes are to be marked "Sealed Bid for Fire Suppression Sprinkler System for District Warehouse" and submitted to the Attention of Dr. Pamela Kibbons, Chief Financial Officer.

At 10:00 AM, all bids will be publicly opened and read aloud at the Round Lake Area Schools CUSD #116 Warehouse, 719 Valentin Drive, Round Lake, IL 60073. School District personnel will transport the bids from the Operations Center to the Warehouse.

Electronic Bid Documents may be obtained, starting at 9:00 AM on Wednesday, June 5, 2024, on the Round Lake Areas Schools CUSD #116 District website. Hard Copies of the Bid Documents are not available.

Invitation for Bids is requesting pricing for Fire Suppression Sprinkler System for District Warehouse.

No bid deposit is required. Bidder also acknowledges their failure to perform within the intent of the bid solicitation may disqualify them from future bidding to the Round Lake Area Schools CUSD 116.
