Attached is an updated draft calendar of key dates for the Elementary School Projects. This version of the calendar is expanded to show all scheduled Board meetings during the review period. While many of the meetings do not require specific action, it is likely that progress updates will be presented during Information and Discussion.

Based on feedback and discussion during the option selection process, a completely revised location and site plan is being developed for the Houserville Elementary project. This new option will be presented to the Facilities and Grounds subcommittee on January 4 and to the full Board on January 9, 2017. Consequently, it is suggested that the Houserville public meeting be moved to January 24 and the Corl Street meeting, which had previously been scheduled for that date, be rescheduled for January 10, the original Houserville date.

As with previous projects, the schedule will follow both an internal 30-60-90% review and approval process, as well as the PlanCon submission process. Both of these processes will lead to an eventual final approval targeted for September 25, 2017.
