The district has received DCED (PA Department of Community & Economic Development) grants for the Radio Park and Houserville projects. These grants were originally projected to be awarded in June; however, the actual award did not occur until July 1, 2016. By delaying the bid award into the next fiscal year, the Department has extended the prescribed substantial completion date for the projects from June 2018 to June 2019. This change allows for some positive changes to the associated project calendars.

The original calendar showed the Board selecting final project options in September, which would have necessitated a highly accelerated design and approval phase of 9 to 10 months. This would then have been followed by another highly accelerated construction phase of about 12 months in order to achieve the deadline.

The new deadline allows a revised calendar with a standard 12-month design and approval phase. This would be followed by adequate time for final document review and bidding and an 18-month construction calendar. Based on the design and construction portion of this calendar, it is recommended that the Board extend the selection process for final project by nearly 2 months, from late September to mid-November.

As part of the recommended calendar changes, the team is recommending that the previously scheduled August 15 Public Forum be postponed. The intended agenda for August 15 would be moved to the already scheduled Forum of September 19 and a new Forum would be added October 17.

A suggested calendar adjustment is attached.
