This discussion includes an updated budget development calendar. Revisions include the addition of all finance committee and board meeting dates. This was reviewed at the finance committee meeting on Nov. 11.

The next required Board action will be to adopt a preliminary general fund budget or adopt the resolution not to exceed the Act 1 Index. The preliminary budget will be presented at the Dec. 7 meeting. The administration will recommend that the board adopt the not to exceed resolution on Jan. 11.

The focus of the finance team for this budget cycle is expected to include:

- Revenue
- Staffing
- Benefits
- Charter school tuition
- Capital including minor capital projects, transfer to capital projects, school bus purchases
- Educational model hybrid and virtual academy
- COVID-19 pandemic expenses

The finance committee will have budget development discussions at the regular monthly meetings. Membership in the CAC for Finance is also being expanded to add to the experienced committee. Input from this group should be beneficial during this important budget development cycle.
