Subject: 2023-2024 State Budget Update

As presented at the <u>September 18, 2023 board meeting</u>, the administration recommends amending the budget to reflect the additional state subsidies included in the state budget allocation in the amount of \$1,891,204.

The recommendation includes a budget amendment to allow new expenditures for this revenue:

Purpose	Amount	Description	
Special Education Teacher	\$ 125,000	Increased enrollment in special education students beyond current staffing capacity. Many of these students were previously enrolled in charter schools.	
Elementary Music - orchestra	\$ 125,000	Due to increased program enrollment, instruction could no longer be provided by current teaching staff.	
Special Education services	\$ 100,000	Increased contracted services based upon required need, not otherwise available.	
Professional Development	\$ 50,000	Staff professional development for safety, recess management, and curriculum. Funding not previously identified in the current budget.	
Transportation Costs	\$ 300,000	Additional contracted carrier fees for increased routes and rates	
Student Activities (extra- and co-curricular)	\$ 150,000	Goal is to increase student extra- and co-curricular opportunities by adding new clubs and develop a lifecycle schedule for equipment, instruments, supplies.	
Curriculum Equipment	\$ 100,000	Develop a lifecycle schedule for curricular equipment.	
Districtwide Facilities Master Plan	\$ 450,000	Consulting and associated costs for facilities master planning.  Note: cannot be funded by capital funds.	
AP Testing	\$ 50,000	Fee waivers for Advanced Placement first-time testtakers.	
Capital Reserve Fund	\$ 441,204	Transfer for future capital projects.
