Once again we invite your district to participate in the Eastern Suffolk BOCES Regional Summer School Consortium.

Below are pertinent informational updates regarding the 2024-2025 Regional Summer School Program.

- Registration for all students of consortium districts will be expedited at their respective high schools by their guidance counselors.
- As of this writing, Regional Summer School will be offered through the **Bay Shore Union Free School District**.
- As part of the consortium, your district will be billed as follows:

<u>BOCES Service</u>	<u>Cost Per Seat</u>
Credit-Bearing Course	\$503
Regents Review Class	\$236
Regents Exam Only	\$140

Should your district choose to join the consortium, registration material will be forwarded to your high school guidance office to facilitate early registration. Please note that these costs are eligible for BOCES aid.

If your district chooses not to participate in the consortium, the cost for the service will be passed directly to the student/family. The chart below summarizes the expected costs.

Regents Review Class	\$157.61
Regents Exam Only	\$93.50

Please note that the deadline for registering for courses is July 10, 2024.

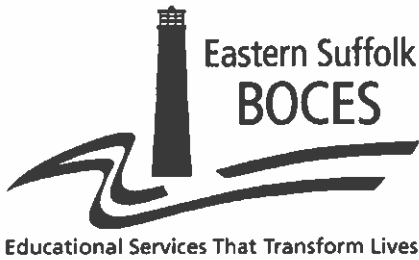
