## **AP US Government and Politics – Summer Assignment**

**Due:** August 22, 2024

**Exam Date:** May 5<sup>th</sup> (*tentative*)

### **Overview of the Course**

This course is designed to be equivalent to a one-semester introductory college course. This course introduces students to key political ideas, institutions, policies, interactions, roles, and behaviors that characterize American political culture. The course examines politically significant concepts and themes, which facilitate applying disciplinary reasoning, assessing causes and consequences of political events and interpreting data to develop evidence-based arguments.

### **Course Content**

The AP U.S. Government & Politics course is organized around five units which focus on major topics in U.S. government and politics. These units are:

- Foundations of American Democracy
- Interaction among Branches of Government
- Civil Liberties and Civil Rights
- American Political Ideologies and Beliefs
- Political Participation

### **The Exam**

The AP exam will take place on **May 5<sup>th</sup>**. As you probably already know, the school requires that anyone enrolled in an AP class takes the AP test. This is a great opportunity for you to demonstrate the knowledge you have acquired and earn college credits at a **severely** discounted price. Three hours long, the exam comprises 55 multiple choice questions and 4 Free Response questions. We will spend time during the year specifically practicing and preparing for the exam itself.

I hope that AP Gov can be a positive place for you to explore the workings of this great country we live in. However, this is a class that is designed to replace an actual college class and will be treated as such. You will be held to high standards and will be expected to put in the work and time associated with a college-level course. I'm always here to help answer questions and assist wherever I can.

### **The Assignment (50 points total):**

**Step 1:** Get some index cards. I know many of you may use Quizlet and after you complete the assignment you are more than welcome to do that as well. However, this will give you the opportunity to blend visual *and* kinesthetic learning as you write out very crucial information that will help you succeed in the class. All index cards must be written in your handwriting. No typed material.

**Step 2:** In order to become familiar with the nine foundational documents you will create an index card for each one. On the index card you should include the following: **(30 points)**
