2020 IRS Form W-4 – Employee's Withholding Certificate

Employees who have furnished Form W-4 in any year before 2020 are **not required** to furnish a new form merely because of the redesign. Onslow County Schools will continue to compute withholding based on the information from the employee's most recently furnished Form W-4. However, completing the New 2020 IRS Form W-4 may make your withholding more accurately match your tax liability due to changes in tax laws. If an employee desires to make changes to their withholdings, the New 2020 IRS Form W-4 will need to be submitted to the Payroll Department. The New 2020 IRS Form W-4 is a complete overhaul of the form unlike any previous W-4 forms. This overhauled form may take some time to review depending on your personal financial situation. In order to determine the right amount of withholdings from your paycheck, we encourage you to review the 2020 IRS Form W-4 completely, check out the Frequently Asked Questions and the Tax Withholding Estimator at www.irs.gov/W4App, and consider obtaining professional tax advice for your personal situation if needed.
