The NWPMS School Improvement Team met to determine the Title I priorities for 2019-20. The team felt that emphasis on reading should continue along with support for students after school through Mastery Monday tutoring with transportation provided and funded through Title I to ensure access to after school instructional support for all students. The team also agreed that additional books were necessary for the higher lexile readers by increasing higher lexile books available for checkout in the media center collection. The team agreed that math should continue to be a primary focus as it was in 2018-19 despite the expected delay in 2018-19 EOG Math results after implementing Ready Math in 2018-19. In addition, the team reviewed current enrollment for 2019-20 and potential class size unanimously agreed to fund one classroom teaching position using Title I funds for the 8th grade.
