New Business

1. Chris Barnes, Executive Director of Instruction and EC Services.
 - a. Movement from Occupational Prep to Employment prep.
 - b. Graduation pathways for special needs, OCS.
 - i. Certain number of work hours and portfolio to graduate
 - ii. Students are not typically looking for 4-year college
 - iii. Most are workforce bound
 - iv. 250 work hours, 150 school-based hours required
 - v. Juniors and seniors should be on job sites working toward a career goal. Supervised by a job coach/TA. Teacher assistants work on job opportunities for these students while in school and after graduation.
 - vi. Criticisms: job placements are janitorial. This is a myth that is trying to overcome and work with business community to expand placements.
 - vii. Staff members can accompany students during the work process.
 - viii. If business feels it is not working, accommodations can be made. Does not need to be a burden on the business. Ultimately, stay in good faith with businesses.
 - ix. Timeline is a semester.
 - x. Mike Riggs from Sanders Ford stated that Swansboro currently works with OCS students twice a week. He feels that if more businesses were involved, they would benefit.

- xi. Possibility of working within Onslow County Schools maintenance, facilities, distribution, etc.
 - xii. William Laine stated that we have Career Development Coordinators at each school that could work with these students as well since they have multiple business contacts through their internship program. COVID has been a setback but back on track.
 - xiii. Mark Sutherland inquired about Coastal Enterprises. Brad Staley mentioned that we have had work-based learning opportunities with them.
 - xiv. Mike Riggs asked about liability insurance for students. Will Laine mentioned that CTE has work-based learning insurance for students and Chris Barnes will look into insurance coverage for EC students.
