# Blind Brook PTA General Meeting Wednesday, January 19, 2021 7:00pm Blind Brook MS/HS IMC (In Person) and Via Zoom **MINUTES**

# I. Acting Superintendent Q&A and Update: Colin Byrne

- A. Update on Ridge Street School construction
  - i. Courtyard is coming along
  - ii. Once courtyard is complete, focus will shift to cafetorium
  - iii. Still plan to finish by the end of this school year
  - iv. District will renew the temporary certificate of occupancy periodically, which means periodic inspections
- B. We had 3 new hires recently:
  - i. Laurie Baum: Interim School Business Official. Will oversee district's finances and facilities this year
  - ii. Stewart Hanson: Interim Director of Health, Nursing, Physical Education and Interscholastic Athletics
  - iii. Kallie Edge: Covid Coordinator
- C. Snow days RSS still has one snow day, the MS/HS has none.
  - i. Q: I didn't know the power outage counted as a snow day. Will there be consideration of holding remote instruction the next time it snows, so that MS/HS students don't lose vacation days? Yes, there will be notice and lead time in advance of a "remote instruction snow day," so that students and teachers can be prepared.
  - ii. I get emails from people who want no-instruction snow days, and from people who want remote instruction snow days. I read everything parents send me and take it into consideration.
- D. COVID update:
  - i. Things have been very confusing the past few weeks.
  - ii. I believe we have appropriate protocols and staff in place now. We will be getting back to parents more quickly.
  - iii. Regarding the testing program- we have revamped it from soup to nuts. We are still hammering out some pieces, like notifying students to pick up and drop off materials. I'm glad people reached out to me saying they didn't get a confirmation- hopefully everyone is caught up and on the list if you want to be on the testing cycle. I've had a few questions about when to expect results: usually it takes 2 to 3 days. The tests will be sent

out every Friday, usually we know by Monday/Tuesday. My goal is to notify everybody of their results, whether the result is positive or negative.

- iv. Q: The state mandates that unvaccinated teachers be tested. Are we on track to test unvaccinated teachers now? Yes, actually the testing of teachers was always going on. It was the voluntary testing of students that we lost track of. Also, more staff have submitted vaccination cards, so fewer need to be tested.
- v. Q: We signed up for a program for tests we've had in school. Are we going to use them at all? There are a good amount of tests sitting in one of the schools, aren't there? Based on the reply to the vaccination survey, we shouldn't need a Test To Stay program. Sometimes we supply a family with tests, if one child tested positive, and the family wants to test siblings. In addition, we'll plan to share out the tests broadly after the next break. Tests are hard to come by; we want to be cognizant of that.
- vi. Q: What happened with the testing that wasn't going on? Where did that communication fall? I can't exactly speak to that. I think someone didn't understand the full scope of the job, and I wasn't following up because I assumed they did, which was my mistake. I want to be sure when things get handed off, that someone understands the work they need to do.
- vii. Q: There's been talk in the news regarding boosters and after school activities. Where does that sit in terms of Blind Brook policy? If you read the NYS regulations, in order for students to participate in after school activities including sports, they have to be vaccinated and boosted. Local superintendents feel that doesn't make sense. We are waiting for the Westchester DOH to weigh in. We are not enforcing the booster part. Superintendents are looking to advocate not to have that piece in because it doesn't make sense, since we are already having students in school all day. For example, a student may be in Drama class during the school day, but not be in an afterschool play because they're not boosted? It doesn't make sense.
- viii. **Q: How can students sign up to attend Homecoming?** Check your email tomorrow. The PTA will have sign ups on Community Pass.
- ix. Q: Regarding snow days, thank you for communicating the current status. Is there a page on the district website where we post the status of snow days? No, we haven't done that. It's an interesting idea; I'm sure we could add that to the calendar page.
- x. Q: Regarding STEAM at RSS: I know that kids have done paper airplanes for a while because the construction has been delayed. I understand that now kids can go to the classroom now and have

proper instruction. I understand supplies are stored away somewhere. Can we have a timeline as to when students will have access to the STEAM supplies? Mrs. Taylor, the STEAM teacher now has a classroom, but she doesn't have the supplies. Our DICE facilitator, Mrs. Burke, is going to go through the materials with Mrs. Taylor and plan lessons with the actual supplies available. Follow Up: Where are the supplies locked up, and could we ask parents to send in supplies? Yes, I was explaining to Mrs. Burke that Mrs. Willig used to ask parents for bottles, shoe boxes, toilet paper rolls, etc, if a project required it. The supplies are currently in the maker space, a room that is not in use right now.

- xi. Comment: Regarding the STEAM class, it has been super disappointing. Our fifth graders have been making paper airplanes for months. Our children tell us how boring it is, and the new Red Riding Hood unit in STEAM is not an appropriate level - it's kindergarten level. Kids do not have access to an engineering program; it's just not fair to our students. Parents are supplementing by paying for the Junior Jellies program at the High School.
- xii. Q: There is a date on the calendar for the 5th grade moving up. Is that the final official date? We've historically done the last Thursday for all of the ceremonies. I'll take a look and get confirmation on that.

- A. We are in the process of electing our new board. Thank you to Alicia for spearheading the nomination committee. The application process will begin soon. One note: in order to be co-president, you need to already be on the executive board.

Patricia reaches out with a phone call and information to new parents who move into the neighborhood. She has lots of materials to hand off to our new ambassador.
