SUPERINTENDENT'S MESSAGE

Dear SVCS Families and Community,

What a year it has been! We are proud of the sense of normalcy the District has been able to maintain by making the school experience as traditional as possible. This would not have been possible without the efforts of our students, teachers, staff or the support of our community.

We are pleased to present you with the 2022-2023 budget for the Stockbridge

Valley Central School District. As always, it is our goal to develop a spending plan that is fiscally responsible to our taxpayers, in both the short and long term, while maintaining the strong education programs that are important to our students' success while addressing missed learning that occurred as a result of the pandemic. We continue to examine all programs with a critical eye to ensure they remain effective and are operated in an efficient manner. We have carefully scrutinized each line of the budget to confirm the proposed spending is necessary and appropriate. We have given great attention to maximize revenues to maintain the long-term financial health of Stockbridge Valley.

The goal of this proposed budget is to provide students with a number of diverse programs, giving them many opportunities to continue to grow and be successful. The proposed budget reflects a 2.18% increase in spending. This increase will provide us with additional opportunities to enhance and maintain our strong programming. This budget maintains all of our current programs. The proposed 2022-2023 tax levy reflects a 1.96% increase from the 2021-2022 budget. The New York State tax cap limit requires districts to apply an eight-step formula to determine the tax levy limit a district can propose. We have applied this formula to determine our tax levy for this proposed budget.

We invite all residents to attend a public hearing on Tuesday, May 10, 2022, at 6:30 p.m. in the Stockbridge Valley Central High School Library to share your thoughts or questions. **The District** will vote on the proposed 2022-2023 budget on Tuesday, May 17, 2022 from 10:00 a.m. until 8:00 p.m.

With the assistance of the Munnsville Volunteer Fire Department and local law enforcement, S.V.C.S. will be conducting an evacuation drill on Wednesday, May 11 at 1:30 p.m. Students will be returning to the building after the drill and dismissal will be at the normal time.







If you are not registered with the County Board of Elections, and if you are a U.S., citizen, eighteen years of age or older, a resident of the school district for at least 30 days before the vote, you may apply for an absentee ballot for the school district vote by contacting the office of the District Clerk at 315-495-4400.




