SUPERINTENDENT'S MESSAGE

Dear Community,

This is a very tough time that we are experiencing together. Thank you for your continued support for the children of this community. It never goes unnoticed how much we can count on this community. The Board of Education (BOE) and the district have worked hard to develop a budget that supports our students and our community.

When preparing the budget each year we hear two things from our community; maintain programs for our students and stay within the allowed tax cap. The BOE and the district have listened to our community. We have also taken a hard look at the districts expenditures through this tough budget year and found efficiencies that allow us to maintain student programs and stay within the tax cap.

The BOE adopted a budget on May 19, 2020 with a tax levy 2.24%, which is within the allowed tax cap. With a STAR, it is an estimated increase of \$31.00 for the year if your home is assessed at \$100,000 and a \$22.00 increase this year if your home is assessed at \$80,000. In either case this is less than a \$3.00 increase each month.

The vote this year cannot be done in person per an executive order from Governor Cuomo. The district will mail an absentee ballot with a return, stamped envelope. If you do not receive a ballot, please call Pam Mennig at 315-495-4400. In the same executive order, Governor Cuomo stated that all votes are due to the district no later than 5:00 p.m. on June 9, 2020. The votes will be counted on June 9, 2020 beginning at 8:00 p.m. We will post a link on the website if you wish to view the vote count.

I hope that you will consider voting for me to serve another term.







REVENUE COMPARISON 2011-12 TO 2020-21




















QUALIFIED VOTER:

A qualified voter is one who is (1) a citizen of the United States of America, (2) eighteen years of age or older, and (3) resident within the School District for a period of thirty (30) days next preceding the annual vote and election.

If you are a not registered with the County Board of Elections, and if you are a U.S, citizen, eighteen years of age or older, a resident of the school district for at least 30 days before the vote, you may apply for an absentee ballot for the school district vote by contacting the office of the clerk at 315-495-4400.








STOCKBRIDGE JUNIOR AUSTIN NOLLEY SELECTED AS THE NYS FFA PRESIDENT


