The mission of the Stockbridge Valley Central School District is the education of all of its students, including but not limited to, the areas of intellectual, social, physical, and psychological growth.



#### **Michael Oot**



I'm Mike Oot, married to Annie, and I live with my two SVCS student children, Emily and Peter on the east side of the Stockbridge Valley. I am an attorney, my wife works in the

school as a Teaching Assistant. I've served on the SVCS School Board before, from 2001 - 2007, five of those years I was lucky enough to serve as the President. I am a co-founder, Vice President and Member of the Board of Directors of the Stockbridge Valley Education Foundation. I have also served

on the Shared Decision Making Committee at the School.

I am running again for the SVCS School Board because I believe that the school has lost it's focus. The evidence for this is clear: This year the school had a choice, they could leave the educational programs intact without risking student performance or they could spend \$200,000 in cash on, rather than finance, school buses. They made the choice to pay the cash for the school buses leaving the school with a budget that reflects the loss of an English teacher, two or three other teaching positions, potentially some class advisors and the loss of a stipend for a very valuable FFA advisor. Those reductions amount to \$180,000, or, put another way, \$20,000 less than the buses. Bad choice. Very bad when you consider that funding for transportation is almost fully aided by the State and Federal Governments and worse, the aid for this will only return to the school slowly, over time, as if they had financed it.

The School Administration also presented to the Board a proposal to pay \$7,500 per year for a grant writing program that would duplicate BOCES services already paid for. Thankfully, the Board didn't approve it. To cut a \$2,000 stipend for an admittedly beneficial FFA adviser and at the same time propose spending \$7,500 on services the taxpayers have already paid for, displays an insensitivity to the dozens of community members who showed up to support the FFA program advisor and reflects an unfortunate set of values.

I deplore the cuts at the school. If you will give me that chance, I will work hard to sharpen the focus of the school on the task of properly allocating taxpayer dollars and generating the only profit a school should have: well educated children; it's those kids standing on the stage at the end of their Senior year, well equipped, well educated and ready to face their next step, whether

college or the world; This is the profit of a school.

#### **John Wagner**



Hello, my name is John Wagner and I am a candidate for re-election to the Stockbridge Valley Central School Board of Education. It has been an extreme pleasure to serve

the last six years representing the residents of the Stockbridge Valley Central School system and with your support I look forward to another three years of service to the students, parents and residents of SVCS. I would like to thank those people who signed my petition and gave me the opportunity to place my name on the ballot.

I reside on Sullivan Road in Munnsville with my son Joshua age 11, who is a student within the Stockbridge Valley school system. I am a 1994 graduate of Stockbridge Valley, 1996 graduate of SUNY Morrisville with an AAS Degree in Agricultural Business and a 1998 graduate of SUNY Cobleskill with a BT Degree in Agricultural Enterprise and Marketing.

Our district is in the midst of some very exciting times, with the recent completion of the EXCEL building

project we have installed much needed building and athletic field upgrades and additions of new technology to our classrooms that will continue to allow us to bring our students the best in education at a cost the taxpayers can afford. I am pleased to report that as promised there is NO local tax impact as a result of the EXCEL building project, New York State building aid revenue will match our expenses for the life of the pay-out of the project resulting in no direct tax impact to District residents. I am proud to say that over the past six years as a member of the board we have not brought forth a tax increase of more than 2% and in the 2007-08 year the increase was 0% and in 2009-10 it was .24%; which I believe is unheard of in this region. We have done all this without significant cuts to program and without lay-offs. We continue to offer the children of our district great educational opportunities and at the same time stay cognizant of our responsibility to the taxpayers of the SVCS District. In my last three years on the board we as a board have been able to NOT use RANS (Revenue Anticipation Notes) to bridge our finances in the Fall of each school year as we await our State Aid payments, thus saving the District the cost of interest on these RANS. We have also been able to purchase our school buses with cash payments each Spring saving the District residents financing and legal fees. I stand by my record of doing what is right for kids at the same time balancing what is right for the taxpayers of the Stockbridge Valley.

Over the past six years I have learned a lot about the education system but still have much to learn and would welcome the voters support in returning me to the board for another three year term so that I can continue my education. In my six years I have had the opportunity to serve as both President for the last two years and previous to that Vice President of the board. I also had the opportunity to serve on the EXCEL

building committee, serve as a member of the board's finance and audit committee and have been given the opportunity to serve as Stockbridge Valley's representative to the Madison-Oneida BOCES board of education.

Many challenges lie ahead for our school district and our community in the coming years. We must be open to change and be willing to look at all the possibilities that exist, we can no longer just continue to do things the way we always have. Our small rural district needs to think outside of the box for solutions to the challenges we face, we cannot expect the Federal or State government to come to our rescue.

#### Tim Green Visit



On Saturday April 2<sup>nd</sup>, members of the Stockbridge Valley FFA Chapter traveled to Lowville to compete in the central region sub-state contests. Chapter members had been preparing since January for their respective career development events.

Sadie Kelly competed in the Senior People in Agriculture contest where she designed a poster about six different careers in agriculture and gave a speech about one of those careers. 

## the bully

Bullies come in all shapes and sizes. Some are big; some are small; some bright and some not so bright; some attractive and some not so attractive; some popular and some disliked by almost everybody.

Bullying is a conscious, willful and deliberate hostile activity, intended to harm.

#### The Four Markers of Bullying

- 1. An imbalance of power
- 2. Intent to harm
- 3. Threat of further aggression
- 4. When bullying escalates unabated—terror

Bullying is not about anger, or even about conflict. It's about contempt—a powerful feeling of dislike toward someone considered to be worthless, inferior or undeserving of respect. Contempt comes with three apparent psychological advantages that allow kids to harm others without feeling empathy, compassion or shame. These are:

- A sense of entitlement—the right to control, dominate, subjugate, and abuse another human being
- 2. An intolerance toward difference
- A liberty to exclude—to bar, isolate, and segregate a person deemed not worthy of respect or care

#### Seven Steps to Stop Bullying

- Discipline (including the three Rs: restitution, resolution, reconciliation)
- 2. Create opportunities to "do good"
- 3. Nurture empathy
- 4. Teach friendship skills
- Closely monitor TV viewing, video games and computer activities
- Engage in more constructive, entertaining, energizing activities
- 7. Teach ways to "will good"

### the bullied

The one thing that all kids who are bullied have in common is that a bully or a bunch of bullies has targeted them. Each one was singled out to be the object of scorn, and thus the recipient of bullying, merely because he or she was different in some way.

#### The Warning Signs

- Shows an abrupt lack of interest in school, or refuses to go to school
- 2. Takes an unusual route to school
- 3. Suffers drop in grades
- 4. Withdraws from family and school activities
- 5. Is hungry after school
- 6. Steals money from home
- 7. Makes a beeline to the bathroom when arriving home
- 8. Is sad, sullen, angry, or scared after receiving a phone call or email
- 9. Does something out of character
- 10. Has torn or missing clothing
- Uses derogatory or demeaning language when talking about peers
- 12. Stops talking about peers and everyday activities
- Has physical injuries not consistent with explanation
- 14. Has stomachaches, headaches, panic attacks, is
- unable to sleep, sleeps too much, is exhausted 15. Plays alone, or prefers to hang with adults

#### Why Kids Don't Tell

- 1. They are ashamed of being bullied
- 2. They are afraid of retaliation
- 3. They don't think anyone can help them
- 4. They don't think anyone will help them5. They've bought into the lie that bullying is
- They've bought into the lie that bullying is a necessary part of growing up
- They might believe that adults are part of the lie—they bully too
- 7. They have learned that "ratting" on a peer is bad, not cool

## the bystander

Bystanders are the third group of players in this tragedy. They are the supporting cast who aid and abet the bully, through acts of omission and commission. They stand idly by or look away, or they can actively encourage the bully or join in and become one of a bunch of bullies. Injustice overlooked or ignored becomes a contagion that infects even those who thought they could turn away.

#### Standing Up and Speaking Out

Bullying is challenged when the majority stands up against the cruel acts of the minority. Establishing new norms, enforcing playground rules, and increasing supervision are policy decisions that can help reduce the incidents of bullying. Since much of the bullying goes on "under the radar of adults," a potent force is kids themselves showing bullies that they will not be looked up to, nor will their cruel behavior be condoned or tolerated. Kids need not be bystanders. They can become active witnesses, standing up for their peers, speaking out against injustices, and taking responsibility for what happened among themselves.

### teasing/taunting

#### Teasing

- 1. Allows the teaser and person teased to swap roles.
- 2. Isn't intended to hurt the other person.
- Maintains the basic dignity of everyone involved.
   Pokes fun in a lighthearted, clever, and benign way.
- Pokes fun in a lighthearted, clever, and ber
   Is meant to get both parties to laugh.
- Is only a small part of the activities shared by kids who have something in common.
- 7. Is innocent in motive.
- Is discontinued when person teased becomes upset or objects to the teasing.

#### Taunting

- 1. Is based on an imbalance of power and is onesided: the bully taunts, the bullied kid is taunted.
- 2. Is intended to harm.
- Involves humiliating, cruel, demeaning, or bigoted comments thinly disguised as jokes.
- 4. Includes laughter directed at the target, not with the target.
- 5. Is meant to diminish the sense of self-worth of the target.
- Induces fear of further taunting or can be a prelude to physical bullying.
- 7. Is sinister in motive.
- Continues especially when targeted kid becomes distressed or objects to the taunt.

## four most powerful antidotes to bullying

Strong sense of self, being a friend, having at least one good friend who is there for you through thick and thin, and being able to successfully get into a group—and get out when it does not serve you well.

## if your child is bullied

#### Don't

- Don't minimize, rationalize, or explain away the bully's behavior.
- 2. Don't rush in to solve the problem for your child.
- 3. Don't tell your child to avoid the bully.
- 4. Don't tell your child to fight back.5. Don't confront the bully or the bully's parents alone.Do's
- I hear you; I am here for you; I believe you; you are not alone in this.
- 2. It is not your fault.
- 3. There are things you can do.
- 4. Report the bullying to school personnel.

## how to report

- Arrange a meeting for you and your child with the appropriate person at the school.
- Bring to the meeting the facts in writing—the date, time, place, kids involved, and the specifics of the incidents—and the impact the bullying has had on your child as well as what your child has done to try to stop the bullying that didn't work.
   Work with your child and school personnel on a
- 5. Work with your child and school personnel on a plan that addresses what your child needs right now in order to feel safe, what she can do to avoid being bullied and to stand up to any future bullying, and whom she can go to for help.
- Find out what procedures the bully will be going through and what kind of support the school is expecting from the parents of the bully.
- 5. If you feel the problem is not being adequately addressed by the school, know that you can express your concerns and let the teacher and/or administrator know that you will take the next step to the school district board office and if necessary—especially in the cases of serious abuse and racist or sexist bullying—to the police.

## caring schools

- Gather information about bullying at school directly from students.
- Establish clear schoolwide and classroom rules about bullying.
- Train all adults in the school to respond sensitively and consistently to bullying.
- Provide adequate adult supervision, particularly in less structured areas, such as on the playground and in the lunchroom.
- Improve parental awareness of and involvement in working on the problem.

## re-writing the script

The bully, the bullied, the bystander—the interactions involved in such role-playing, though commonplace in our culture, are not healthy, not normal, certainly not necessary, and in fact are devastating to the children playing them. We as parents and educators can rewrite the script and create for our children alternative, healthier roles that require no pretense and no violence. With care and commitment, we can rechannel the behaviors of the bully into positive leadership activities; acknowledge the nonaggressive behaviors of the bullied child as strengths that can be developed and are honored; and transform the role of the bystander into that of a witness, someone willing to stand up, speak out, and act against injustice. A daunting task, but a necessary one.


